AN ACT

- 1 Amending the act of February 1, 1966 (1965 P.L.1656, No.581),
- 2 entitled "An act concerning boroughs, and revising, amending
- and consolidating the law relating to boroughs, " authorizing
- 4 business set-asides for minority and small businesses.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The act of February 1, 1966 (1965 P.L.1656,
- 8 No.581), known as The Borough Code, is amended by adding a
- 9 section to read:
- 10 Section 1402.1. Minority and Small Business Set-aside.--(a)
- 11 The following words and phrases when used in this section shall
- 12 have, unless the context clearly indicates otherwise, the
- 13 meanings given to them in this section:
- 14 "Business set-aside" means that percentage of each borough
- 15 contract or package of contracts, determined by the ordinance or
- 16 resolution of council, for which bids are to be solicited only
- 17 <u>from minority and small businesses.</u>
- 18 "Total set-aside" means bids for the entire contract are to

- 1 be solicited only from minority and small businesses.
- 2 <u>"Partial set-aside" means a portion of the contract,</u>
- 3 <u>determined by the ordinance or resolution of council, where bids</u>
- 4 will only be solicited from minority and small businesses.
- 5 (b) (1) The borough shall, upon designation of a business
- 6 <u>set-aside</u> as <u>determined</u> by <u>council</u>, <u>include</u> <u>such</u> <u>designation</u> in
- 7 the advertisement for bids in the media used to solicit bids.
- 8 (2) In the case of contracts designated as a business set-
- 9 <u>aside</u>, invitations to bid shall be confined to small and
- 10 minority businesses and bids from other businesses shall be
- 11 <u>rejected</u>. The contract shall be awarded to the lowest
- 12 responsible bidder among such businesses in accordance with the
- 13 ordinance or resolution or rules and regulations for purchasing
- 14 promulgated by council. Awarding of contracts to businesses
- 15 under this section is subject to all other provisions of this
- 16 act governing procurement and all rules promulgated thereunder,
- 17 as now or hereafter amended, except as altered by this section
- 18 and the ordinances or rules and regulations promulgated in its
- 19 administration.
- 20 (3) In the event the borough, when it solicits a bid, feels
- 21 that responsive competitive bids at reasonable prices were not
- 22 obtained as a result of the business set-aside solicitation, or
- 23 that bids thereof were received only from firms demonstrated to
- 24 be not responsible, it may request that council cancel the
- 25 business set-aside designation. Council action must be taken on
- 26 the request within thirty days of receipt. Upon the approval of
- 27 the cancellation by council, the procurement will be
- 28 readvertised on an unrestricted basis. Small and minority
- 29 <u>business bidding firms will be notified of the business set-</u>
- 30 aside cancellation, the reasons for the bid rejection, and the

- 1 borough's intent to readvertise the procurement on an
- 2 <u>unrestricted basis. No business set-aside shall be cancelled</u>
- 3 unless council has determined from all available evidence that
- 4 either no qualified firms or individuals are bidding on the
- 5 projected contract or that responding firms are incapable of
- 6 performing for reasonable price expectations.
- 7 (c) Council shall be responsible for carrying out the
- 8 policies of this section and to the extent consistent with the
- 9 best interests of the borough shall attempt to locate additional
- 10 qualified small and minority business suppliers by all
- 11 appropriate methods, particularly where only a limited number of
- 12 small and minority business concerns are on bidders' lists.
- 13 Section 2. This act shall take effect in 60 days.
