- 17 Section 2. Payments to the University of Pennsylvania on
- 18 account of the appropriations for the items provided in section
- 19 1 shall be made quarterly by the Secretary of Education on the
- 20 basis of costs during the fiscal year.
- 21 Section 3. The University of Pennsylvania shall provide such
- 22 information and in such form and manner as the Department of
- 23 Education may prescribe.
- 24 Section 4. The University of Pennsylvania shall report its
- 25 revenues and expenditures and present its financial statements
- 26 in accordance with generally accepted accounting principles and
- 27 procedures for educational institutions as set forth in the
- 28 "Higher Education Finance Manual of 1975," without exception.
- 29 Section 5. This act shall take effect July 1, 1983 or, if
- 30 enacted subsequent to that date, then immediately.
