AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania 2 Consolidated Statutes, providing for the suspension of
- drivers' licenses or the right to apply for driver's licenses
- 4 of persons under 21 years of age who are convicted or plead
- 5 to certain crimes relating to intoxicating beverages.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 6308 of Title 18 of the Pennsylvania
- 9 Consolidated Statutes is amended to read:
- 10 § 6308. Purchase, consumption, possession or transportation of
- intoxicating beverages.
- 12 (a) Offenses defined. -- A person commits a summary offense if
- 13 he, being less than 21 years of age, attempts to purchase,
- 14 purchases, consumes, possesses or transports any alcohol, liquor
- 15 or malt or brewed beverages.
- 16 (b) Withdrawal or denial of operating privilege.--In
- 17 <u>addition to the penalty for the offense:</u>
- 18 (1) If the person convicted pleads quilty or nolo
- 19 contendere and holds a Pennsylvania driver's license, the

- driver's license shall be suspended for one year for the
- 2 <u>first offense</u>, <u>suspended two years for a second offense and</u>
- 3 <u>suspended four years for a third offense.</u>
- 4 (2) If the person convicted pleads quilty or nolo
- 5 <u>contendere</u>, does not hold a Pennsylvania driver's license and
- 6 <u>is between 16 and 21 years of age, the privilege of applying</u>
- 7 <u>for a driver's license shall be denied for one year following</u>
- 8 the conviction or plea for the first offense, two years for a
- 9 second offense and four years for a third offense.
- 10 (3) If the person convicted pleads guilty or nolo
- 11 contendere and is under 16 years of age, the privilege of
- 12 applying for a driver's license shall be denied until the
- 13 person reaches 17 years of age for a first offense, 19 years
- of age for a second offense and 23 years of age for a third
- offense.
- 16 Section 2. This act shall take effect in 60 days.
