AN ACT

- Providing for the provisions of poultry and egg contracts; and 2 imposing civil penalties.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 5 Section 1. Findings and purpose.
- The General Assembly hereby finds: 6
- That the poultry and egg industries in Pennsylvania
- are vital to the health and welfare of all Pennsylvanians. 8
- That all segments of these industries, including 9
- 10 farmers, brokers, processors and retailers, need to be
- 11 financially secure in order for the industry to benefit the
- citizens of this Commonwealth. 12
- 13 (3) That, at present, poultry and egg farmers often do
- 14 business without having any guarantee of payment.
- 15 That if poultry and egg farmers are not financially

- 1 secure, these industries would collapse, thereby threatening
- 2 the jobs, health and welfare of thousands of Pennsylvanians.
- 3 Section 2. Definitions.
- 4 The following words and phrases when used in this act shall
- 5 have the meanings given to them in this section unless the
- 6 context clearly indicates otherwise:
- 7 "Grower." A person who provides physical facilities for
- 8 housing and labor for raising poultry, whether or not he
- 9 provides additional services incidental to the raising of
- 10 poultry.
- "Merchant." A person who buys poultry DIRECTLY FROM THE FARM <---
- 12 in wholesale quantities within this Commonwealth, including, but
- 13 not limited to, purchases on commission, purchases by a dealer
- 14 or purchases by a broker.
- 15 "Person." Any individual, partnership, sole proprietorship,
- 16 corporation or entity.
- 17 "PERSONAL SERVICE." ACTUAL DELIVERY OF WRITTEN NOTICE TO THE <---
- 18 PERSON TO WHOM IT IS DIRECTED OR TO SOMEONE AUTHORIZED TO
- 19 RECEIVE IT IN HIS BEHALF.
- 20 "Poultry." All types of chickens, whether raised to be sold
- 21 as layers or for processing, chicken eggs, ducks, geese, turkeys
- 22 and all game birds raised for processing.
- 23 "Poultry contract." Any agreement, either oral or written,
- 24 between a grower and a merchant relating to the raising of
- 25 poultry by the grower.
- 26 Section 3. Time for payment.
- 27 Unless otherwise agreed to IN WRITING by the parties
- 28 involved, all sums due to a grower by a merchant under a poultry
- 29 contract shall be paid to the grower within 14 21 days of the
- 30 date on which the grower delivers the poultry to the merchant.

- 1 Section 4. Interest on late payments.
- 2 Beginning on the 15th 22ND day after the date of delivery,

- 3 the merchant shall be liable to the grower for interest on the
- 4 unpaid balance. Unless otherwise agreed to by the parties
- 5 involved, the interest is to be simple interest at the rate
- 6 published by the Secretary of Revenue pursuant to section 806 of
- 7 the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal
- 8 Code.
- 9 Section 5. Mortgages or other security given by growers to
- 10 merchants.
- 11 Unless otherwise agreed to by the parties involved, a
- 12 mortgage or other security given by a grower, as mortgagor or
- 13 obligor, to a merchant or his assignee or designee, as mortgagee
- 14 or obligee, shall be satisfied by the merchant upon either of
- 15 the following conditions: (i) the delivery of the grown flock of
- 16 birds to the merchant by the grower; or (ii) the making of a
- 17 declaration of default by a grower under section 6. Such a
- 18 mortgage or other security shall not be deemed to be a
- 19 continuing obligation, but shall cease and determine when either
- 20 of the conditions set forth in this section are met.
- 21 Section 6. Failure to pay grower.
- 22 In the event that a grower is not paid by a merchant within
- 23 the time specified in section 3, the grower may, in addition to
- 24 other remedies provided in law, in equity or in other sections
- 25 of this act, declare the merchant to be in default under any
- 26 contract entered into with the merchant. Upon notice to the
- 27 merchant of such a declaration and of the date and place IN THE <
- 28 EVENT OF DEFAULT, A CONTINUING SECURITY INTEREST AGREED TO BY
- 29 BOTH PARTIES SHALL BE SATISFIED BY THE PARTY WHO OWES THE DEBT.
- 30 SECTION 6. FAILURE TO PAY GROWER.

- 1 (A) REMEDIES OF GROWER.--IN THE EVENT THAT A GROWER IS NOT
- 2 PAID BY A MERCHANT WITHIN THE TIME SPECIFIED IN SECTION 3 OR IS
- 3 NOT PAID BY A MERCHANT WHO FILES A PETITION IN BANKRUPTCY, THE
- 4 GROWER MAY, IN ADDITION TO OTHER REMEDIES PROVIDED IN LAW, IN
- 5 EQUITY AND IN THIS ACT, DECLARE THE MERCHANT TO BE IN DEFAULT
- 6 UNDER ANY CONTRACT ENTERED INTO WITH THE MERCHANT. UPON WRITTEN
- 7 NOTICE TO THE MERCHANT, TO THE SECRETARY OF AGRICULTURE AND TO
- 8 THE SECURED PARTIES OF RECORD, AND IN THE EVENT OF BANKRUPTCY,
- 9 TO THE BANKRUPTCY COURT, OF SUCH A DECLARATION AND OF THE DATE
- 10 AND PLACE of the proposed sale, the grower shall have a lien
- 11 upon any property of the merchant, including poultry, then in
- 12 the grower's possession, which lien shall take priority over any
- 13 previously perfected security interest in the property. This
- 14 property shall be sold NOT LESS THAN 14 DAYS AFTER THE MERCHANT <-
- 15 RECEIVES WRITTEN NOTICE, and the proceeds of sale shall be
- 16 applied in the manner provided in 13 Pa.C.S. § 9504 (relating to
- 17 right of secured party to dispose of collateral after default;
- 18 effect of disposition). A buyer of the property shall,
- 19 notwithstanding any other provision of law to the contrary, take
- 20 the property free of any security interest. Notice WRITTEN
- 21 NOTICE under this section shall be given by personal service or
- 22 by certified mail to the merchant at his last known address.
- 23 (B) REMEDIES OF MERCHANT.--BEFORE A PROPOSED SALE MAY TAKE
- 24 PLACE, THE SECRETARY OF AGRICULTURE SHALL EVALUATE DISPUTES
- 25 BETWEEN THE GROWER AND THE MERCHANT OVER LATE PAYMENT WITHIN 14
- 26 DAYS OF WRITTEN NOTICE OF DEFAULT AT THE REQUEST OF EITHER OF
- 27 THE INVOLVED PARTIES.
- 28 Section 7. Provisions of act may not be waived.
- The provisions of this act are to ensure, for all of the
- 30 citizens of this Commonwealth, an adequate supply of poultry

- 1 products. The provisions of this act may not be waived, altered,
- 2 amended or otherwise avoided by contract. An attempted waiver,
- 3 alteration or amendment shall be unenforceable in the courts of
- 4 this Commonwealth and is hereby deemed to be void from its
- 5 inception. This section shall have no effect on the terms of a
- 6 contract that are not inconsistent with the provisions of this
- 7 act.
- 8 Section 8. Rights of unpaid grower.
- 9 (a) Civil action authorized. -- A grower who is not paid
- 10 within 14 21 days or who is not paid interest on a late payment, <
- 11 as provided in sections 3 and 4, may bring a civil action
- 12 against the merchant in a county where the grower resides or
- 13 does business or in any other county provided by law or rule of
- 14 court.
- 15 (b) Court may award costs.--In an action instituted under
- 16 this section, the court, in issuing a final order, may award
- 17 costs of litigation, including reasonable attorney and expert
- 18 witness fees, to the grower, whenever the court determines that
- 19 such an award is appropriate.
- 20 Section 9. Civil penalties.
- 21 A person who is found in default under section 6 more than
- 22 twice within a 12-month period shall be subject to a civil
- 23 penalty equal to twice the amount of each late payment. The
- 24 Secretary of Agriculture shall have the authority to bring a
- 25 civil action to impose this penalty AND TO REVOKE ANY RELATED
- 26 LICENSES OF THE DEFAULTING MERCHANTS WITHIN THE JURISDICTION OF

- 27 THE DEPARTMENT OF AGRICULTURE.
- 28 Section 10. Application.
- 29 For a period of two years from the effective date of this
- 30 act, this act shall not apply to poultry contracts which are in

- 1 effect prior to the effective date of this act.
- 2 Section 11. Effective date.
- This act shall take effect in 90 days. 3
