## AN ACT

1 2 3 4 5	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, requiring school buses to stop at all railroad crossings; and permitting local authorities to designate and use roads for nonvehicular purposes; AND FURTHER PROVIDING FOR LIMITED EXEMPTIONS FROM THE AXLE TAX.
6	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. Section 3342 of Title 75 of the Pennsylvania
9	Consolidated Statutes is amended to read:
L O	§ 3342. Vehicles required to stop at railroad crossings.
L1	(a) General rule Except as provided in subsection [(b)]
L2	(c), the driver of any vehicle described in regulations issued
L3	pursuant to subsection [(c)] (d), before crossing at grade any
L 4	track or tracks of a railroad, shall stop the vehicle within 50
L5	feet but not less than 15 feet from the nearest rail of the
L6	railroad and while so stopped shall listen and look in both

directions along the track for any approaching train, and for

signals indicating the approach of a train, and shall not

- 1 proceed until it can be done safely. After stopping and upon
- 2 proceeding when it is safe to do so the driver of the vehicle
- 3 shall cross only in such gear of the vehicle that there will be
- 4 no necessity for manually changing gears while traversing the
- 5 crossing and the driver shall not manually shift gears while
- 6 crossing the track or tracks.
- 7 (b) School buses.--Notwithstanding the provisions of
- 8 paragraphs (2), (3) and (4) of subsection (c), the drivers of
- 9 school buses shall stop before crossing any railroad grade
- 10 crossing or track or tracks of a railroad.
- [(b)] (c) Exceptions.--This section does not apply at any of
- 12 the following:
- 13 (1) Any railroad grade crossing at which traffic is
- controlled by a police officer or flagman.
- 15 (2) Any railroad grade crossing at which traffic is
- 16 regulated by a traffic-control signal.
- 17 (3) Any railroad grade crossing protected by crossing
- 18 gates or an alternately flashing light signal intended to
- 19 give warning of the approach of a railroad train.
- 20 (4) Any railroad grade crossing at which an official
- 21 traffic-control device gives notice that the stopping
- 22 requirement imposed by this section does not apply.
- 23 [(c)] (d) Regulations defining vehicles subject to
- 24 section. -- The department shall adopt such regulations as may be
- 25 necessary describing the vehicles which must comply with the
- 26 stopping requirements of this section. In formulating the
- 27 regulations, the department shall give consideration to the
- 28 hazardous nature of any substance carried by the vehicle as
- 29 determined by the Hazardous Substances Transportation Board and
- 30 to the number of passengers carried by the vehicle in

- 1 determining whether the vehicle shall be required to stop. These
- 2 regulations shall be developed in conjunction with the
- 3 Pennsylvania Public Utility Commission and the Urban Mass
- 4 Transportation Authority and shall correlate with and so far as
- 5 possible conform to the current regulations of the United States
- 6 Department of Transportation.
- 7 Section 2. Section 6109 of Title 75 is amended by adding a
- 8 subsection to read:
- 9 § 6109. Specific powers of department and local authorities.
- 10 \* \* \*
- 11 (g) Play highways.--Local authorities may designate any
- 12 <u>highway or any part of a highway under their jurisdiction a</u>
- 13 "play highway," and may close such designated highway to general
- 14 traffic where interference to traffic will not be serious. Such
- 15 <u>highways or portions of highways shall be used for play purposes</u>
- 16 and shall be clearly designated by appropriate signs, specifying
- 17 the hours between which such highways shall be closed to general
- 18 traffic.
- 19 SECTION 3. TITLE 75 IS AMENDED BY ADDING A SECTION TO READ: <
- 20 § 9910. AGRICULTURAL EXEMPTION.
- 21 THE PROVISIONS OF THIS CHAPTER SHALL NOT APPLY TO A TRUCK,
- 22 TRUCK TRACTOR OR COMBINATION WHICH IS USED SOLELY FOR
- 23 AGRICULTURAL OR FARMING PURPOSES, CARRIES PRODUCTS PRODUCED BY
- 24 THE OWNER AND IS OWNED AND OPERATED BY A NONRESIDENT IN FULL
- 25 COMPLIANCE WITH THE REGISTRATION REQUIREMENTS OF THE PLACE OF
- 26 RESIDENCE OF THE OWNER.
- 27 Section  $\frac{3}{4}$ . This act shall take effect in 60 days.
