AN ACT

- 1 Relating to the control of vegetation within the right-of-way of
- 2 highways; providing for applications, inspections and
- 3 permits; and fixing penalties.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Highway
- 8 Vegetation Control Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Department." The Department of Transportation.
- 14 "Obstruction of view." When the intent of the advertising is
- 15 not discernible for a total of five seconds in the viewing zone.
- 16 "Off-premises outdoor advertising device." An outdoor
- 17 advertising device as defined by, and for which a permit has

- 1 been issued pursuant to the act of December 15, 1971 (P.L.596,
- 2 No.160), known as the Outdoor Advertising Control Act of 1971,
- 3 or for which a permit has been issued pursuant to any local
- 4 ordinance, and which advertises activities not conducted on the
- 5 property on which it is located.
- 6 "On-premises outdoor advertising device." An outdoor
- 7 advertising device which advertises activities conducted on the
- 8 property on which it is located.
- 9 "Outdoor advertising device" or "device." Both on-premises
- 10 outdoor advertising devices and off-premises outdoor advertising
- 11 devices.
- 12 "Screening" or "screened." The obstruction of view of a
- 13 device as viewed from the center of the lane of traffic of the
- 14 highway and from a height of no more than 60 inches above the
- 15 highway surface.
- 16 "Vegetation." All woody and herbaceous plants.
- 17 "Viewing zone." That distance measured along the center of
- 18 the lane of traffic of a highway which a vehicle will travel at
- 19 the posted speed limit.
- 20 Section 3. Application; permit.
- 21 (a) Contents. -- The owner of any device which is screened by
- 22 vegetation may make application to the department for a permit
- 23 to take remedial action as provided in this act. Such
- 24 application shall contain the following information:
- 25 (1) the name, address and telephone number of the
- 26 applicant;
- 27 (2) the location of the device, including the route
- number of the highway, side of the road and distance and
- 29 direction of the nearest identifying landmark;
- 30 (3) the advertising displayed on the device;

- 1 (4) the kind, size and location of vegetation for which
- 2 remedial action is requested;
- 3 (5) the type of remedial action requested; and
- 4 (6) the permit number, if any, if the device is an off-
- 5 premises outdoor advertising device.
- 6 (b) Form.--The department may by regulation adopt and
- 7 promulgate a form for the application to take remedial action;
- 8 provided, however, if no such form has been adopted and
- 9 promulgated on or before the effective date of this act, any
- 10 application to take remedial action shall be complete if it
- 11 contains the information set forth in subsection (a).
- 12 (c) Fee.--The department may charge a permit fee of \$30 \$90
- 13 for each application.
- 14 Section 4. Action by department.
- 15 (a) Inspection. -- The department shall inspect the device and
- 16 surrounding vegetation to determine whether or not to grant the
- 17 permit. The applicant shall be advised by the department when
- 18 such inspection shall occur so that the applicant, if the
- 19 applicant so desires, may be present during such inspection.
- 20 (b) Notice of action taken.--Within 30 days of the filing of
- 21 the application, it shall either be approved or disapproved. If
- 22 the application is approved, the permit immediately shall be
- 23 issued. If the application is disapproved, the department shall
- 24 provide to the applicant an explanation setting forth the
- 25 reasons for the disapproval and the manner in which the
- 26 application may be corrected or modified or both in order to
- 27 obtain the permit. If the application is disapproved and if the
- 28 applicant determines that said application may not be corrected
- 29 or modified based on the reasons set forth by the department,
- 30 the applicant may appeal to the Commonwealth Court within 30

- 1 days of such disapproval.
- 2 (c) Automatic approval. -- If the application neither is
- 3 approved nor disapproved within 30 days of the filing thereof,
- 4 the application shall be deemed to be approved and the permit
- 5 shall be deemed to have been granted immediately.
- 6 (d) Life of permit. -- The permit issued or deemed to be
- 7 issued shall be valid for a period of 120 days from the date the
- 8 application is approved or deemed to have been approved.
- 9 Section 5. Bonds.
- 10 The department may require an applicant to whom a permit has
- 11 been issued to post a blanket bond covering all work to be done
- 12 pursuant to all permits issued to an applicant, to insure and
- 13 protect the Commonwealth against loss or damage to trees or
- 14 vegetation for which remedial action has not been approved or
- 15 deemed to be approved and occasioned by pruning, trimming,
- 16 relocation or removal of trees or vegetation and to require the
- 17 applicant to indemnify the department for the replacement cost
- 18 of any such trees or vegetation so damaged or destroyed. The
- 19 amount of the bond shall be determined by the department and
- 20 shall bear a reasonable relation to the nature of the work being
- 21 done by the applicant.
- 22 Section 6. Remedial action.
- 23 (a) Permissible action.--If the application is approved or
- 24 deemed to be approved and the permit has been granted or deemed
- 25 to have been granted, the permit may authorize all or any of the
- 26 following action:
- 27 (1) The applicant may raise or lower or adjust the
- device to reduce the conflict with the vegetation so as to
- eliminate, as nearly as possible, the screening.
- 30 (2) The applicant may prune or trim the vegetation to

- 1 reduce or eliminate the screening.
- 2 (3) The applicant may prune, trim, relocate or remove
- 3 individual plants in the vegetation to reduce or eliminate
- 4 the screening.
- 5 (b) Safety.--Any activity by an approved applicant shall not
- 6 create an abnormal safety hazard or interfere with the flow of
- 7 traffic.
- 8 Section 7. Relief from liability for damages.
- 9 Where persons are working under a permit granted pursuant to
- 10 this act, the Commonwealth shall not be liable for any damages
- 11 to persons or property resulting therefrom.
- 12 Section 8. Rules and regulations.
- 13 The department shall promulgate rules and regulations
- 14 necessary to implement and to carry out the provisions of this
- 15 act.
- 16 Section 9. Application of act.
- 17 This act shall only apply to outdoor advertising devices
- 18 lawfully erected.
- 19 Section 10. Unlawful acts; penalties.
- 20 (a) Permit necessary. -- It shall be unlawful for any owner of
- 21 a device to prune, trim, relocate or remove any vegetation so as
- 22 to reduce or eliminate screening, unless such owner has been
- 23 granted a permit pursuant to this act.
- 24 (b) Screening prohibited.--Neither the department, nor
- 25 anyone acting pursuant to orders from the department, shall
- 26 plant vegetation otherwise permitted by section 410 of the act
- 27 of June 1, 1945 (P.L.1242, No.428), known as the State Highway
- 28 Law, so as to result in screening of any device lawfully erected
- 29 prior to such planting.
- 30 (c) Fine.--Violation of this act or of a permit issued under

- 1 this act shall be a summary offense punishable by a fine of \$100
- 2 to \$300 plus the value of any vegetation destroyed or the cost
- 3 of restoration at the option of the department.
- 4 Section 11. Limitation.
- 5 No provision of this act is intended to conflict with the
- 6 intent of the Federal act of October 22, 1965 (Public Law 89-
- 7 285), known as the Highway Beautification Act of 1965, or with
- 8 normal conservation practices.
- 9 Section 12. Effective date.
- 10 This act shall take effect in 60 days.
