## AN ACT

- Amending the act of June 24, 1931 (P.L.1206, No.331), entitled
  "An act concerning townships of the first class; amending,
  revising, consolidating, and changing the law relating
  thereto," further providing for advertisements relating to
  contracts.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 1802(a) of the act of June 24, 1931
- 9 (P.L.1206, No.331), known as The First Class Township Code,
- 10 reenacted and amended May 27, 1949 (P.L.1955, No.569) and
- 11 amended December 22, 1981 (P.L.535, No.154), is amended to read:
- 12 Section 1802. General Regulations Concerning Contracts.--(a)
- 13 All contracts or purchases made by any township, involving the
- 14 expenditure of over four thousand dollars, except those
- 15 hereinafter mentioned, shall not be made except with and from
- 16 the lowest responsible bidder, shall be in writing, and shall be
- 17 made only after notice by the secretary, published, in one
- 18 newspaper of general circulation, published or circulating in

- 1 the county in which the township is situated, at least [three]
- 2 <u>two</u> times at intervals of not less than three days where daily
- 3 newspapers of general circulation are employed for such
- 4 publication, or in case weekly newspapers are employed then the
- 5 notice shall be published once a week for two successive weeks.
- 6 The first advertisement shall be published not more than forty-
- 7 <u>five days and the second advertisement</u> not less than ten days
- 8 prior to the date fixed for the opening of bids. Advertisements
- 9 for contracts or purchases shall also be posted in a conspicuous
- 10 place within the township. All plans and specifications shall be
- 11 on file at least ten days in advance of opening bids. The amount
- 12 of the contract shall in all cases, whether of straight sale
- 13 price, conditional sale, bailment lease, or otherwise, be the
- 14 entire amount which the township pays to the successful bidder
- 15 or his assigns in order to obtain the services or property, or
- 16 both, and shall not be construed to mean only the amount which
- 17 is paid to acquire title or to receive any other particular
- 18 benefit or benefits of the whole bargain.

- 20 Section 2. This act shall take effect in 60 days.
