AN ACT

- Amending the act of December 1, 1977 (P.L.249, No.83), entitled 2 "An act prohibiting employers from firing employees who lose 3 time from employment in the line of duty as volunteer firemen 4 and providing penalties, " providing for inclusion of special 5 police officers along with fire police or auxiliary 6 personnel.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 8
- 9 Sections 1, 3 and 4 of the act of December 1, Section 1.
- 10 1977 (P.L.249, No.83), entitled "An act prohibiting employers
- 11 from firing employees who lose time from employment in the line
- 12 of duty as volunteer firemen and providing penalties," are
- 13 amended to read:
- 14 Section 1. No employer shall terminate an employee who is a
- 15 volunteer fireman or fire police or auxiliary or special police
- officer and in the line of duty has responded to a call prior to 16
- the time he was due to report for work resulting in a loss of 17
- 18 time from his employment.

- 1 Section 3. Any employee losing time as provided in section 1
- 2 shall supply his employer with a statement from the chief of his
- 3 volunteer fire company or from his chief of police stating that
- 4 he responded to a call and the time thereof.
- 5 Section 4. As used in this act, "line of duty" shall mean
- 6 going to, coming from or during fire prevention and safety
- 7 activities which includes fire prevention, police action, first
- 8 aid, rescue and salvage, ambulance service, fire police work,
- 9 assistance at accidents, <u>traffic control</u>, control of crowds both
- 10 on the fire grounds and at occasions of public or general
- 11 assembly, animal rescue, abatement of conditions due to storm,
- 12 flood or general peril, abatement or removal of hazards to
- 13 safety and such other activities as are commonly undertaken by
- 14 fire companies and their affiliated organizations. The term
- 15 "employer" includes any individual, partnership, association,
- 16 corporation, business trust, or any person or group of persons
- 17 acting directly or indirectly in the interest of an employer in
- 18 relation to any employee.
- 19 Section 2. This act shall take effect in 60 days.
