AN ACT

- Amending the act of July 31, 1968 (P.L.805, No.247), entitled, 2 as amended, "An act to empower cities of the second class A, 3 and third class, boroughs, incorporated towns, townships of 4 the first and second classes including those within a county 5 of the second class and counties of the second class A 6 through eighth classes, individually or jointly, to plan 7 their development and to govern the same by zoning, 8 subdivision and land development ordinances, planned 9 residential development and other ordinances, by official 10 maps, by the reservation of certain land for future public purpose and by the acquisition of such land; to promote the 11 12 conservation of energy through the use of planning practices 13 and to promote the effective utilization of renewable energy 14 sources; providing for the establishment of planning 15 commissions, planning departments, planning committees and 16 zoning hearing boards, authorizing them to charge fees, make 17 inspections and hold public hearings; providing for appropriations, appeals to courts and penalties for 18 19 violations; and repealing acts and parts of acts, "providing 20 for retirement communities.
- 21 The General Assembly of the Commonwealth of Pennsylvania
- 22 hereby enacts as follows:
- 23 Section 1. Section 107 of the act of July 31, 1968 (P.L.805,
- 24 No.247), known as the Pennsylvania Municipalities Planning Code,
- 25 is amended by adding a clause to read:

- 1 Section 107. Definitions.--As used in this act, except where
- 2 the context clearly indicates otherwise, the following words or
- 3 phrases have the meanings indicated below:
- 4 * * *
- 5 (18.2) "Retirement community," any group of structures
- 6 <u>designed as an integrated development for the purpose of</u>
- 7 providing primary residential living quarters for retired
- 8 individuals; and which may include such amenities and facilities
- 9 <u>as recreational areas, nursing homes, medical center or other</u>
- 10 <u>health care related facilities or both.</u>
- 11 * * *
- 12 Section 2. Section 604 of the act is amended by adding a
- 13 clause to read:
- 14 Section 604. Zoning Purposes.--The provisions of zoning
- 15 ordinances shall be designed:
- 16 * * *
- 17 (4) To promote, protect and facilitate the development of
- 18 retirement communities within the municipality. Retirement
- 19 communities are recognized as a legitimate residential use and
- 20 the same shall be permitted either by right, by special
- 21 exception or as a conditional use in any district within the
- 22 municipality which allows the construction and erection of
- 23 single family homes.
- 24 Section 3. This act shall take effect in 60 days.
