AN ACT

1 2 3 4 5 6 7 8 9 10 11 2 3 14 15	Amending the act of November 26, 1975 (P.L.438, No.124), entitled, as amended, "An act establishing child protective services; providing procedures for reporting and investigating the abuse of children; establishing and providing access to a Statewide central register and pending complaint file on child abuse; investigating such reports; providing for taking protective action including taking a child into protective custody; placing duties on the Department of Public Welfare and county children and youth social service agencies; establishing child protective services in each county children and youth social service agency; and providing penalties," further providing for the provision and regulation of child care services and recordkeeping duties; and requiring certain persons to furnish information of criminal history.

18	Section 1. The definition of "child care" in section 3 of
19	the act of November 26, 1975 (P.L.438, No.124), known as the
20	Child Protective Services Law, is repealed.
21	Section 2. Section 3 of the act is amended by adding a
22	definition to read:
23	Section 3. DefinitionsAs used in this act:

"Child care services" means child day care centers, foster 2 homes, adoptive parents, boarding homes, juvenile detention 3 center services or programs for delinquent or dependent 4 children; mental health, mental retardation and drug and alcohol 5 services for children; and any other child services which are 6 provided by or subject to approval, licensure, registration or 7 8 certification by the Department of Public Welfare or the 9 Department of Health or a county social services agency or which are provided pursuant to a contract with these departments or a 10 11 county social services agency. * * * 12 13 Section 3. Section 14(i) of the act, amended June 10, 1982 (P.L.460, No.136), is amended to read: 14 15 Section 14. Record Keeping Duties of the Department. --* * * 16 The Statewide central register shall include and shall (i) 17 be limited to the following information: the names, social 18 security numbers, age and sex of the subjects of the reports; 19 the date or dates and the nature and extent of the alleged 20 instances of suspected child abuse; the home addresses of 21 subjects of the report; the county in which the suspected abuse 22 occurred; family composition; the name and relationship to the 23 abused child of the person or persons responsible for causing the abuse; the source of the report; services planned or 24 25 provided; whether the report is a founded report, an indicated 26 report; and the progress of any legal proceedings brought on the 27 basis of the report of suspected child abuse. * * * 28 Section 4. 1	Section 23.1. Regulation of Day CHILD Care Services(a)
2	This section shall apply to all prospective employees of child
3	care services, including independent contractors and their
4	employees and foster parents except those employees and
5	independent contractors and their employees who have no direct
6	contact with children.
7	(b) Administrators of child care services shall require
8	prospective employees to submit with their applications for
9	employment, the following information, which shall be no more
10	than one year old:
11	(1) A report of criminal history record information from the
12	<u>Pennsylvania State Police or a statement from the Pennsylvania</u>
13	State Police that the central repository contains no such
14	information relating to that person. Such criminal history
15	record information shall be limited to that which is
16	disseminated pursuant to 18 Pa.C.S. § 9121(b)(2) (relating to
17	general regulations).
18	(2) A certification from the department as to whether the
19	applicant is named in the central register as the perpetrator of
20	a founded or indicated report of child abuse.
21	(c) For the purposes of this section, an applicant may
22	submit a copy of the required information with his or her
23	application for employment. Administrators shall require
24	applicants to produce the original document prior to employment.
25	(d) In determining suitability of an applicant for
26	employment based on criminal history record information,
27	administrators shall comply with regulations promulgated by the
28	department.
29	<u>(e) In no case shall an administrator hire an applicant</u>
30	where the department has verified that the applicant is named in

1	the central register as the perpetrator of a founded report of

3	(f) The department shall, in the manner provided by law,
4	promulgate the regulations necessary to carry out this section.
5	These regulations shall:
6	(1) Set forth criteria for unsuitability for employment in a
7	child care service in relation to criminal history record
8	information. Such criteria shall be reasonably related to the
9	prevention of child abuse.
10	(2) Set forth sanctions for administrators who wilfully hire
11	applicants in violation of subsection (d) or in violation of the
12	regulations promulgated hereunder.
13	(3) Provide for the confidentiality of information obtained
14	pursuant to subsection (b).
15	(g) The department shall require persons seeking to operate
16	child care services to comply with subsection (b).
17	(h) The department may charge a fee not to exceed \$10 in
18	order to conduct the certification as required in subsection
19	<u>(b)(2).</u>
20	(i) The department shall comply with certification requests
21	no later than ten days from the receipt of the request.
22	(j) The department shall develop a procedure for the
23	voluntary certification of child caretakers, to allow persons to
24	apply to the department for a certificate indicating the person
25	has met the requirements of subsection (b). The department shall
26	also provide for the annual recertification of such persons.
27	(k) The Department of Health shall promulgate regulations
28	setting forth sanctions for administrators of services approved,
29	certified or licensed by that department who wilfully hire
30	applicants in violation of subsection (e) or in violation of the

2 (L) THE REQUIREMENTS OF THIS SECTION SHALL NOT APPLY TO
3 EMPLOYEES OF CHILD CARE SERVICES WHO MEET ALL THE FOLLOWING
4 REQUIREMENTS:
5 (1) THE EMPLOYEES ARE UNDER 21 YEARS OF AGE.

6 (2) THEY ARE EMPLOYED FOR PERIODS OF 90 DAYS OR LESS.

7 (3) THEY ARE A PART OF A JOB DEVELOPMENT AND/OR JOB TRAINING
8 PROGRAM FUNDED IN WHOLE OR IN PART BY PUBLIC OR PRIVATE SOURCES.
9 ONCE EMPLOYMENT OF A PERSON WHO MEETS THESE CONDITIONS EXTENDS
10 BEYOND 90 DAYS, ALL REQUIREMENTS OF THIS SECTION SHALL TAKE
11 EFFECT.

Section 6. (a) Sections 1 and 4 of this act shall take seffect immediately.
