AN ACT

1 Amending the act of April 9, 1929 (P.L.177, No.175), entitled
2 "An act providing for and reorganizing the conduct of the
3 executive and administrative work of the Commonwealth by the
4 Executive Department thereof and the administrative
5 departments, boards, commissions, and officers thereof,
6 including the boards of trustees of State Normal Schools, or
7 Teachers Colleges; abolishing, creating, reorganizing or
8 authorizing the reorganization of certain administrative
9 departments, boards, and commissions; defining the powers and
10 duties of the Governor and other executive and administrative
11 officers, and of the several administrative departments,
12 boards, commissions, and officers; fixing the salaries of the
13 Governor, Lieutenant Governor, and certain other executive
14 and administrative officers; providing for the appointment of
15 certain administrative officers, and of all deputies and
16 other assistants and employees in certain departments, boards,
17 and commissions; and prescribing the manner in which the
18 number and compensation of the deputies and all other
19 assistants and employees of certain departments, boards and
20 commissions shall be determined," providing for the payment
21 of expenses of industries in State correctional facilities.

22 The General Assembly of the Commonwealth of Pennsylvania
23 hereby enacts as follows:

24 Section 1. The act of April 9, 1929 (P.L.177, No.175), known
25 as The Administrative Code of 1929, is amended by adding a
26 section to read:

27 Section 902-B. Payment of Expenses of Industries in

1 Facilities.--In addition to any other provision for payment
2 authorized by law, the Department of Corrections may pay for
3 expenses necessary for the proper conduct of the work of the
4 department pertaining to the establishment, maintenance and
5 carrying on of industries in the State penal and correctional
6 facilities and the rehabilitation of the inmates thereof:

7 (1) Out of any appropriation for the general operation of
8 the department unless the appropriation expressly prohibits such
9 payment.

10 (2) Out of any appropriation that specifically authorizes
11 the making of such payments.

12 Section 2. All acts and parts of acts are repealed insofar
13 as they are inconsistent with this act.

14 Section 3. This act shall take effect in 60 days.
