AN ACT

- Amending the act of August 5, 1941 (P.L.752, No.286), entitled 2 "An act regulating and improving the civil service of certain 3 departments and agencies of the Commonwealth; vesting in the 4 State Civil Service Commission and a Personnel Director 5 certain powers and duties; providing for classification of positions, adoption of compensation schedules and 7 certification of payrolls; imposing duties upon certain 8 officers and employes of the Commonwealth; authorizing 9 service to other State departments or agencies and political 10 subdivisions of the Commonwealth in matters relating to civil service; defining certain crimes and misdemeanors; imposing 11 penalties; making certain appropriations, and repealing 12 13 certain acts and parts thereof," further providing for the political activities of individuals covered by civil service. 14 The General Assembly of the Commonwealth of Pennsylvania

- hereby enacts as follows: 16
- 17 Section 1. Section 904 of the act of August 5, 1941
- 18 (P.L.752, No.286), known as the Civil Service Act, amended
- 19 August 27, 1963 (P.L.1257, No.520), is amended to read:
- 20 Section 904. Prohibition of Political Activity. --
- Notwithstanding any other provision of State law or regulations 21
- adopted thereunder, employes of the classified service shall 22

- 1 have the full right to actively participate in political
- 2 <u>management and political campaigns except as provided hereafter</u>
- 3 <u>in this section and sections 905 and 906.</u> No person in the
- 4 classified service shall [be a member of or delegate or
- 5 alternate to any political convention, nor shall he participate
- 6 at any such convention, except in the performance of his
- 7 official duty or as a visitor, nor shall he serve as a member of
- 8 any committee of any political party, or take an active part in
- 9 political management or in political campaigns, or] use his
- 10 office or position to influence political movements or to
- 11 influence the political action of any officer or employe in the
- 12 classified service, [nor shall he circulate or seek signatures
- 13 to any nominations or other petition required by any primary or
- 14 election law, nor shall he seek or accept election, nomination
- 15 or appointment as an officer of a political club or
- 16 organization, or serve as a member of a committee of any such
- 17 club or organization, nor shall he in any manner participate in
- 18 or interfere with the conduct of any election or the preparation
- 19 therefor at the polling place or with the election officers
- 20 while counting the votes or returning the election material to
- 21 the place provided by law for that purpose, save only for the
- 22 purpose of making and depositing his own ballot as speedily as
- 23 it reasonably can be done, nor shall he be within the polling
- 24 place or within fifty feet thereof, except for the purpose of
- 25 carrying out official duties and of ordinary travel or residence
- 26 during the period of time beginning with one hour preceding the
- 27 opening of the polls for holding such election and ending with
- 28 the time when the election officers shall have finished counting
- 29 the votes and have left the polling place for the purpose of
- 30 depositing the election material in the place provided by law

- 1 for that purpose, excepting only police officers, who may
- 2 temporarily approach or enter the polling place in order to make
- 3 any arrest permitted by law or for the purpose of preserving
- 4 order and in each case remain only long enough to accomplish the
- 5 duties aforesaid after which the said officers shall at once
- 6 withdraw: Provided, however, That the rights of any individual
- 7 as a citizen are not impaired hereby, and the prerogative to
- 8 attend meetings, to hear or see any candidate or nominee, nor to
- 9 express one's individual opinion, shall remain inviolate.] or
- 10 any other person or directly or indirectly coerce, attempt to
- 11 coerce or command a State or local officer or employe or any
- 12 other person to pay, lend or contribute anything of value to a
- 13 party, committee, organization, agency or person for political
- 14 purposes. No person in the classified service shall be a
- 15 candidate for public office in any partisan election, including
- 16 <u>a primary election: Provided, however, That candidacy for</u>
- 17 political party office, even in a partisan election, is not
- 18 prohibited.
- 19 Section 2. Section 905 of the act is amended to read:
- 20 Section 905. Prohibition of Assessments. -- No person shall
- 21 orally or by written or printed communication, directly or
- 22 indirectly, demand, solicit, collect or receive or be in any
- 23 manner concerned in demanding, soliciting, collecting or
- 24 receiving any money or valuable thing or any assessment,
- 25 subscription or contribution, whether voluntary or involuntary,
- 26 from any officer or employe in the classified service for any
- 27 political purpose [whatever] whatsoever as a condition of their
- 28 employment or continued employment, except that solicitation for
- 29 voluntary contributions of classified service employes by their
- 30 registered political action committees shall be permitted. No

- 1 person in the classified service shall orally or by written or
- 2 printed communication, directly or indirectly, demand, solicit,
- 3 collect or receive or be in any manner concerned in demanding,
- 4 soliciting, collecting or receiving any money or valuable thing
- 5 for any political purpose whatever. No person in the service of
- 6 the Commonwealth shall remove, suspend, furlough, demote or
- 7 promote or in any manner change the official status or
- 8 compensation of any other person in the classified service or
- 9 promise or threaten to do so for withholding or neglecting to
- 10 make any contribution of money or service or other valuable
- 11 thing for any political purpose. [No person shall take part in
- 12 preparing any political assessment, subscription or contribution
- 13 with the intent that the same shall be sent or presented to or
- 14 collected from any person in the classified service, and no
- 15 person shall knowingly send or present, directly or indirectly,
- 16 in person or by letter, any political assessment, subscription
- 17 or contribution to, or request its payment by, any person in the
- 18 classified service.]
- 19 Section 3. This act shall take effect in 60 days.
