## AN ACT

Amending Title 71 (State Government) of the Pennsylvania 2 Consolidated Statutes, further providing for creditable 3 nonstate service. 4 The General Assembly of the Commonwealth of Pennsylvania 5 hereby enacts as follows: Section 1. Section 5304(c) of Title 71 of the Pennsylvania 6 7 Consolidated Statutes, amended June 13, 1985 (P.L.40, No.19), is amended to read: 8 § 5304. Creditable nonstate service. 10 (c) Limitations on nonstate service. -- Creditable nonstate 11 service credit shall be limited to: 12 13 intervening military service; 14 other military service not exceeding five years; 15 service in any public school or public educational institution in any state other than this Commonwealth or in 16 any territory or area under the jurisdiction of the United 17

States; or service as an administrator, teacher, or

- department of the government of the United States, whether or

- 4 States, the total of such service not exceeding the lesser of
- 5 ten years or the number of years of active membership in the

- 18 Section 2. Section 5505 of Title 71 is amended by adding a
- 19 subsection to read:
- 20 § 5505. Contributions for the purchase of credit for
- 21 creditable nonstate service.

- 23 (f) Purchase of Federal civil service credit.--
- 24 Contributions on account of credit for service as a Federal
- 25 <u>civil service employee under section 5304(c)(6) (relating to</u>
- 26 <u>creditable nonstate service</u>) shall be equal to the present value
- 27 of the full actuarial cost of the increase in the projected
- 28 <u>superannuation annuity caused by the additional service</u>
- 29 <u>credited</u>. The amount contributed under this subsection shall not
- 30 be payable as a lump sum under section 5705(a)(4)(iii) (relating

- 1 to member's options).
- 2 Section 3. This act shall take effect in 60 days.
