## AN ACT

- 1 Empowering certain local taxing authorities to provide
- 2 exemptions from taxation for certain improvements made to
- 3 certain unimproved residential property.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the New Home
- 8 Construction Local Tax Abatement Act.
- 9 Section 2. Construction.
- 10 This act shall be construed to authorize local taxing
- 11 authorities to exempt improvement to certain unimproved
- 12 residential property implementing section 2(b)(iv) of Article
- 13 VIII of the Constitution of Pennsylvania.
- 14 Section 3. Definitions.
- 15 The following words and phrases when used in this act shall
- 16 have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:

- 1 "Improvement." The erection or construction of one or more
- 2 residential buildings in compliance with laws, ordinances or
- 3 regulations governing such actions.
- 4 "Local taxing authority." A county, city, borough,
- 5 incorporated town, township, school district or home rule
- 6 municipality having authority to levy real property taxes.
- 7 "Municipal governing body." A city, borough, incorporated
- 8 town, township or home rule municipality.
- 9 "Unimproved residential property." Any unimproved real
- 10 estate owned by an individual, association, corporation or
- 11 governmental entity located in this Commonwealth, which is or
- 12 may be zoned, in accordance with the provisions of the act of
- 13 July 31, 1968 (P.L.805, No.247), known as the Pennsylvania
- 14 Municipalities Planning Code, for residential use.
- 15 Section 4. New residential construction.
- 16 (a) Power to grant exemptions.--Each local taxing authority
- 17 may, by ordinance or resolution, exempt from real property
- 18 taxation the assessed valuation of improvements to unimproved
- 19 residential property in the amounts and in accordance with the
- 20 provisions and limitations set forth in this act. Prior to the
- 21 adoption of the ordinance or resolution authorizing the granting
- 22 of tax exemptions, the municipal governing body by ordinance or <-

- 23 resolution shall affix the boundaries of the unimproved
- 24 residential property or properties wholly or partially located
- 25 within its jurisdiction for which the tax exemption shall be
- 26 <del>available. The</del> THE municipal governing body shall conduct at
- 27 least one public hearing for the purpose of determining the
- 28 boundaries DISCUSSION OF THE PROVISIONS OF THE ORDINANCE,
- 29 INCLUDING, BUT NOT LIMITED TO, THE ABATEMENT PERIOD AND THE
- 30 EXEMPTION SCHEDULE. At the public hearing, local taxing

- 1 authorities, planning commissioners, redevelopment authorities,
- 2 and other public and private agencies, individuals, associations
- 3 and corporations which are knowledgeable and interested in the
- 4 improvement of unimproved residential property shall present
- 5 their recommendations. concerning the location of boundaries of <-
- 6 the unimproved residential property or properties for the
- 7 guidance of the municipal governing bodies. The ordinance or
- 8 resolution adopted by a local taxing authority shall specify a
- 9 description of the boundaries of the unimproved residential
- 10 property or properties as determined by the municipal governing
- 11 body, the cost of improvements per dwelling unit to be exempted,
- 12 and the schedule of taxes exempted.
- 13 (b) Cooperation between municipalities.--Two or more
- 14 municipal governing bodies may join together for the purpose of
- 15 determining the boundaries of the unimproved residential
- 16 property and to establish the uniform maximum cost per dwelling

- 17 unit, and the municipal governing bodies shall cooperate fully
- 18 with each other for the purposes of implementing this act. The
- 19 local taxing authorities may, by implementing ordinance or
- 20 resolution, agree to adopt tax exemptions contingent upon the
- 21 similar adoption by an adjacent local taxing authority or by a
- 22 local taxing authority with mutual jurisdiction, within the
- 23 limitations provided herein.
- 24 (c) Limitation.--In the event a local taxing authority
- 25 enacts an abatement ordinance under section 4(a) of this act and
- 26 subsequently amends the ordinance to shorten the abatement
- 27 period provided for in the original or latest version of the
- 28 ordinance, the taxing authority shall not reduce the abatement
- 29 period for those property owners eligible for and participating
- 30 in the previously enacted abatement program. In the event a

- 1 local taxing authority enacts an abatement ordinance under
- 2 section 4(a) of this act and subsequently amends the ordinance
- 3 to extend the abatement period provided for in the original or
- 4 latest version of the ordinance, the taxing authority may extend
- 5 the abatement period for those property owners eligible for and
- 6 participating in the previously enacted abatement program:
- 7 Provided, however, That in no case shall the original period
- 8 plus the extension result in an abatement period that exceeds
- 9 two years.
- 10 Section 5. Exemption schedule.
- 11 (a) Amount of exemption. -- A local taxing authority granting
- 12 a tax exemption pursuant to this act may provide for tax
- 13 exemption on the assessment attributable to the actual cost of
- 14 improvements or up to any maximum cost uniformly established by
- 15 the local taxing authority. The maximum cost shall apply
- 16 uniformly to all eligible unimproved residential property within
- 17 the local taxing authority jurisdiction.
- 18 (b) Schedule of taxes.--Whether or not the assessment
- 19 eligible for exemption is based upon actual cost or a maximum
- 20 cost, the actual amount of taxes exempted shall be in accordance
- 21 with the schedule of taxes exempted established by the local
- 22 taxing authority, subject to the following limitations:
- 23 (1) The length of the schedule of taxes exempted, which
- shall be known as the abatement period, shall not exceed two
- 25 years.
- 26 (2) The schedule of taxes exempted shall stipulate the
- 27 portion of improvements to be exempted each year.
- 28 (3) The exemption from taxes shall be limited to the
- 29 additional assessment valuation attributable to the actual
- 30 cost of improvements to the property or not in excess of the

- 1 maximum cost per unit established by the local taxing
- 2 authority.
- 3 Section 6. Procedure for obtaining an exemption.
- 4 (a) Notification.--Any person desiring tax exemption,
- 5 pursuant to ordinances or resolutions adopted pursuant to this
- 6 act, shall notify each local taxing authority granting the
- 7 exemption on a form provided by the local taxing authority. The
- 8 form shall be submitted at the time the person desiring tax
- 9 exemption secures the building permit, or if no building permit
- 10 or other notification of improvement is required, at the time
- 11 the person commences construction. A copy of the exemption
- 12 request shall be forwarded to the Board of Assessment and
- 13 Revision of Taxes or other appropriate assessment agency. The
- 14 assessment agency shall, after completion of the improvement,
- 15 assess separately the improvement and calculate the amounts of
- 16 the assessment eligible for tax exemption in accordance with the
- 17 limits established by the local taxing authorities and notify
- 18 the taxpayer and local taxing authorities of the reassessment
- 19 and the amounts of the assessment eligible for exemption.
- 20 Appeals from the reassessment and the amounts eligible for the
- 21 exemption may be taken by the taxpayer or the local taxing
- 22 authorities as provided by law.
- 23 (b) Application of changes. -- Except as may be authorized in
- 24 section 4(c), the cost of improvements to be exempted and the
- 25 schedule of taxes exempted existing at the time of the
- 26 submission of the form as provided in subsection (a) shall be
- 27 applicable to that exemption request.
- 28 Section 7. Effective date.
- 29 This act shall take effect immediately.
