## AN ACT

- Amending the act of April 14, 1972 (P.L.233, No.64), entitled "An act relating to the manufacture, sale and possession of controlled substances, other drugs, devices and cosmetics; 4 conferring powers on the courts and the secretary and Department of Health, and a newly created Pennsylvania Drug, 6 Device and Cosmetic Board; establishing schedules of 7 controlled substances; providing penalties; requiring 8 registration of persons engaged in the drug trade and for the 9 revocation or suspension of certain licenses and registrations; and repealing an act, " requiring mandatory 10 sentences for certain drug sales; and further authorizing 11 12 arrest without warrant.
- 13 The General Assembly of the Commonwealth of Pennsylvania
- 14 hereby enacts as follows:
- 15 Section 1. Section 14 of the act of April 14, 1972 (P.L.233,

- 1 No.64), known as The Controlled Substance, Drug, Device and
- 2 Cosmetic Act, amended October 26, 1972 (P.L.1048, No.263), is
- 3 amended to read:
- 4 Section 14. Distribution to Persons Under Age Eighteen. -- (a)
- 5 Any person who is at least twenty-one years of age and who is
- 6 not himself a drug dependent person who violates this act by
- 7 distributing a controlled substance listed in Schedules I
- 8 through V to a person under eighteen years of age who is at
- 9 least four years his junior is punishable by a term of
- 10 imprisonment up to twice that otherwise authorized by subsection
- 11 (f) of section 13 of this act, in addition to any fine
- 12 authorized by this act.
- (b) Any person who sells, delivers, offers for sale or holds
- 14 for sale to a person under eighteen years of age cocaine or any
- 15 of its derivatives, heroin or analogues of a controlled
- 16 <u>substance classified in Schedule I, II or III shall be</u>
- 17 <u>sentenced</u>, <u>upon conviction</u>, <u>to a mandatory term of imprisonment</u>
- 18 of not less than fifteen years notwithstanding any other
- 19 provision of this act or any other statute to the contrary.
- 20 (1) For purposes of this section, an "analogue" means a
- 21 <u>chemical compound designed structurally similar to another but</u>
- 22 differing only by a single element of the same valence and group
- 23 of the periodic table as the element it replaces.
- 24 (2) Any person convicted of a second or subsequent offense
- 25 <u>of this subsection shall be imprisoned for a term of twice the</u>
- 26 <u>term authorized</u>.
- 27 Section 2. Section 34(c)(3) of the act is amended to read:

- 29 (c) The secretary may designate specific officers and
- 30 employes of the Bureau of Drug Control as law enforcement

- 4 act committed in his presence, or if he has probable cause to
- 5 believe that the person to be arrested has committed or is
- 6 committing a violation of this act which may constitute a felony

- 9 Section 3. This act shall take effect in 60 days.
