## A SUPPLEMENT

- To the act of July 3, 1984 (P.L.583, No.117), entitled "An act 2 providing for the capital budget for the fiscal year 1984-3 1985," itemizing transportation assistance projects, to be constructed or acquired or assisted by the Department of 4 5 Transportation, together with their estimated financial costs; authorizing the incurring of debt without the approval 7 of the electors for the purpose of financing the projects to be constructed or acquired or assisted by the Department of Transportation; stating the estimated useful life of the 9 10 projects; and making appropriations.
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. Short title.
- 14 This act shall be known and may be cited as the First
- 15 Supplemental Transportation Assistance Capital Budget Project
- 16 Itemization Act for 1984-1985.
- 17 Section 2. Total authorization.
- 18 The total authorization for the capital projects in the
- 19 category of transportation assistance projects itemized in
- 20 section 3 with respect to which an interest is to be acquired in

- 1 or constructed by the Department of Transportation, its
- 2 successors or assigns, and to be financed by the incurring of
- 3 debt, shall be \$16,000,000.
- 4 Section 3. Itemization of transportation assistance projects.
- 5 Additional capital projects in the category of transportation
- 6 assistance projects for mass transit in which an interest is to
- 7 be acquired in or constructed by the Department of
- 8 Transportation, its successors or assigns, and to be financed by
- 9 the incurring of debt, are hereby itemized, together with their
- 10 estimated financial costs, as follows:
- 11 Total
- 12 Project
- 13 Project Allocation
- 14 (1) Southeastern Pennsylvania Transportation
- 15 Authority
- 16 (i) For transit and rail vehicle overhaul,
- including but not limited to, engines,
- transmissions, air conditioning, electrical
- 19 systems and interior furnishings overhaul
- for buses and motors, transformers,
- 21 compressors, air conditioning systems and
- 22 electrical systems overhaul for rail
- 23 vehicles 16,000,000
- 24 The availability of these funds to the Southeastern Pennsylvania
- 25 Transportation Authority is contingent upon the operation during
- 26 fiscal year 1987 of all transit and regional rail routes in
- 27 existence as of October 1, 1986.
- 28 Section 4. Debt authorization.
- 29 The Governor, Auditor General and State Treasurer are hereby
- 30 authorized and directed to borrow, from time to time, in

- 1 addition to any authorization heretofore or hereafter enacted,
- 2 on the credit of the Commonwealth, subject to the limitations
- 3 provided in the current capital budget, money not exceeding in
- 4 the aggregate the sum of \$16,000,000 as may be found necessary
- 5 to carry out the acquisition and construction of the
- 6 transportation assistance projects specifically itemized in a
- 7 capital budget.
- 8 Section 5. Issue of bonds.
- 9 The indebtedness authorized in this act shall be incurred,
- 10 from time to time, and shall be evidenced by one or more series
- 11 of general obligation bonds of the Commonwealth in such
- 12 aggregate principal amount for each series as the Governor,
- 13 Auditor General and State Treasurer shall determine, but the
- 14 latest stated maturity date shall not exceed the estimated
- 15 useful life of the projects being financed as stated in section
- 16 6.
- 17 Section 6. Estimated useful life and term of debt.
- 18 (a) Estimated useful life. -- The General Assembly states that
- 19 the estimated useful life of the transportation assistance
- 20 projects is as follows:
- 21 (1) Rolling stock, 15 years.
- 22 (2) Passenger buses, 12 years.
- 23 (3) Furniture and equipment, 10 years.
- 24 (4) All others, 30 years.
- 25 (b) Term of debt.--The maximum term of the debt authorized
- 26 to be incurred under this act is 30 years.
- 27 Section 7. Appropriations.
- 28 The net proceeds of the sale of the obligations authorized in
- 29 this act are hereby appropriated from the Capital Facilities
- 30 Fund to the Department of Transportation in the maximum amount

- 1 of \$16,000,000 to be used by it exclusively to defray the
- 2 financial cost of the transportation assistance projects
- 3 specifically itemized in a capital budget. After reserving or
- 4 paying the expenses of the sale of the obligation, the State
- 5 Treasurer shall pay to the Department of Transportation the
- 6 moneys as required and certified by it to be legally due and
- 7 payable.
- 8 Section 8. Federal funds.
- 9 In addition to those funds appropriated in section 7, all
- 10 moneys received from the Federal Government for the projects
- 11 specifically itemized in this act are also hereby appropriated
- 12 for those projects.
- 13 Section 9. Effective date.
- 14 This act shall take effect immediately.
