## AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, providing for preparation and examination of applicants for drivers' licenses regarding the effects of 3
- 4 alcohol and drug use on highway safety and for the acceptance
- 5 of identification cards as a form of identification; further
- 6 providing for certain vehicles to stop at railroad crossings,
- 7 for certain combinations of towed vehicles and for the
- 8 penalties for certain subsequent convictions.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 10
- Section 1. Section 1508 of Title 75 of the Pennsylvania 11
- 12 Consolidated Statutes is amended by adding a subsection to read:
- 13 § 1508. Examination of applicant for driver's license.
- \* \* \* 14
- 15 (c) Alcohol and drug use information. -- The traffic laws
- examination shall contain at least one question relating to the 16
- driver's ability to understand the effects of alcohol and drug 17
- 18 use on highway safety or the provisions of section 1547
- 19 (relating to chemical testing to determine amount of alcohol or
- controlled substance). The driver's manual shall include a 20
- section relating to the effects of alcohol and drug use on 21
- highway safety, along with the related penalties. 2.2
- 23 Section 2. Section 1510 of Title 75 is amended by adding a
- 24 subsection to read:
- 25 § 1510. Issuance and content of driver's license.
- 26 \* \* \*
- 27 (e) Use of identification cards.--If a person has an
- established policy of accepting a driver's license issued 28
- pursuant to subsection (a) for the purpose of identification for 29
- 30 the acceptance of a check given for payment of purchase or for
- the cashing of a check, the person shall also accept an 31
- identification card issued pursuant to subsection (b) for the 32

- 1 same purpose. It shall be a defense to a prosecution under this
- 2 <u>subsection that the person was not presented with notice of the</u>
- 3 provisions of this subsection.
- 4 Section 3. Sections 3342, 4904(h) and 6503 of Title 75 are
- 5 amended to read:
- 6 § 3342. Vehicles required to stop at railroad crossings.
- 7 (a) General rule.--Except as provided in subsection [(b)]
- 8 (c), the driver of any vehicle described in regulations issued
- 9 pursuant to subsection [(c)] (d), before crossing at grade any
- 10 track or tracks of a railroad, shall stop the vehicle within 50
- 11 feet but not less than 15 feet from the nearest rail of the
- 12 railroad and while so stopped shall listen and look in both
- 13 directions along the track for any approaching train, and for
- 14 signals indicating the approach of a train, and shall not
- 15 proceed until it can be done safely. After stopping and upon
- 16 proceeding when it is safe to do so the driver of the vehicle
- 17 shall cross only in such gear of the vehicle that there will be
- 18 no necessity for manually changing gears while traversing the
- 19 crossing and the driver shall not manually shift gears while
- 20 crossing the track or tracks.
- 21 (b) School buses. -- A school bus, whether or not carrying
- 22 passengers, shall stop at all railroad crossings designated by
- 23 appropriate signs, signals or markers except those crossings at
- 24 which traffic is controlled by a police officer or flagman.
- 25 [(b)] (c) Exceptions.--[This] Except as provided in
- 26 <u>subsection (b), this</u> section does not apply at any of the
- 27 following:
- 28 (1) Any railroad grade crossing at which traffic is
- 29 controlled by a police officer or flagman.
- 30 (2) Any railroad grade crossing at which traffic is

- 1 regulated by a traffic-control signal.
- 2 (3) Any railroad grade crossing protected by crossing
- 3 gates or an alternately flashing light signal intended to
- 4 give warning of the approach of a railroad train.
- 5 (4) Any railroad grade crossing at which an official
- 6 traffic-control device gives notice that the stopping
- 7 requirement imposed by this section does not apply.
- 8 [(c)] (d) Regulations defining vehicles subject to
- 9 section. -- The department shall adopt such regulations as may be
- 10 necessary describing the vehicles which must comply with the
- 11 stopping requirements of this section. In formulating the
- 12 regulations, the department shall give consideration to the
- 13 hazardous nature of any substance carried by the vehicle as
- 14 determined by the [Hazardous Substances Transportation Board]
- 15 <u>department</u> and to the number of passengers carried by the
- 16 vehicle in determining whether the vehicle shall be required to
- 17 stop. These regulations shall be developed in conjunction with
- 18 the Pennsylvania Public Utility Commission and the Urban Mass
- 19 Transportation Authority and shall correlate with and so far as
- 20 possible conform to the current regulations of the United States
- 21 Department of Transportation.
- 22 § 4904. Limits on number of towed vehicles.
- 23 \* \* \*
- 24 (h) Certain combinations permitted under section 4968.--
- 25 Combinations consisting of a truck and one trailer or a truck
- 26 tractor and one trailer which exceeds the maximum vehicle
- 27 lengths authorized in section 4923 (relating to length of
- 28 <u>vehicles</u>) and which shall not exceed 102 inches in width, or a
- 29 truck tractor and no more than two trailers, each trailer of
- 30 which [trailers] shall not exceed 102 inches in width and 28 1/2

- 1 feet in length [and shall] may be operated under a permit issued
- 2 under section 4968 (relating to permit for movement during
- 3 course of manufacture)[, may be driven on any highway].
- 4 § 6503. Subsequent convictions of certain offenses.
- 5 Every person convicted of a second or subsequent violation of
- 6 any of the following provisions shall be sentenced to pay a fine
- 7 of not less than \$200 nor more than \$1,000 or to imprisonment
- 8 for not more than [one year] six months, or both:
- 9 Section 1501(a) (relating to drivers required to be
- 10 licensed).
- 11 Section 1543 (relating to driving while operating
- 12 privilege is suspended or revoked).
- Section 3367 (relating to racing on highways).
- 14 Section 3733 (relating to fleeing or attempting to elude
- police officer).
- Section 3734 (relating to driving without lights to avoid
- identification or arrest).
- 18 Section 3748 (relating to false reports).
- 19 Section 4. (a) The amendment to section 1510 shall take
- 20 effect in 120 days.
- 21 (b) The remainder of this act shall take effect in 60 days.
