AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the 2 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 5 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 6 7 Teachers Colleges; abolishing, creating, reorganizing or 8 authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and 9 10 duties of the Governor and other executive and administrative 11 officers, and of the several administrative departments, 12 boards, commissions, and officers; fixing the salaries of the 13 Governor, Lieutenant Governor, and certain other executive 14 and administrative officers; providing for the appointment of 15 certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, 16 and commissions; and prescribing the manner in which the 17 number and compensation of the deputies and all other 18 19 assistants and employes of certain departments, boards and commissions shall be determined, "further providing for 20 21 professional and occupational affairs. THE POWERS AND DUTIES 22 OF THE COMMISSIONER OF PROFESSIONAL AND OCCUPATIONAL AFFAIRS.

- hereby enacts as follows:

- 9 ASSURE THAT NOTICE IS PUBLISHED in a newspaper of general
- 10 <u>circulation in the area where the licensee</u>, <u>certificate holder</u>

- 12 <u>examining boards</u> LICENSING BOARD OR COMMISSION conducts or
- 13 recently conducted his or her practice, of any order suspending

- 15 <u>satisfactorily progressing in a rehabilitation program and the</u>

- 18 THIS CLAUSE SHALL NOT APPLY IN THOSE CASES IN WHICH A PERSON
- 19 ENTERS INTO AN AGREEMENT WITH A BOARD OR COMMISSION TO
- 20 PARTICIPATE IN AN APPROVED TREATMENT PROGRAM FOR IMPAIRED
- 21 PROFESSIONALS AND THE ENFORCEMENT OF THAT PERSON'S SUSPENSION OR
- 22 REVOCATION IS STAYED IN ACCORDANCE WITH THAT AGREEMENT. THIS
- 23 CLAUSE SHALL SUPERSEDE ANY POWER OR DUTY OF A BOARD OR
- 24 COMMISSION UNDER ANY OTHER PROVISION OF LAW TO PUBLISH NOTICE IN
- 25 <u>A NEWSPAPER OF GENERAL CIRCULATION OF DISCIPLINARY ACTION TAKEN</u>
- 26 BY THAT BOARD OR COMMISSION.
- 27 (B) IN ADDITION TO THE POWERS AND DUTIES IMPOSED UNDER THE
- 28 PROVISIONS OF SUBSECTION (A) HEREOF, THE COMMISSIONER OF
- 29 PROFESSIONAL AND OCCUPATIONAL AFFAIRS SHALL BE [AN EX-OFFICIO] A
- 30 MEMBER OF EACH OF THE SAID BOARDS.

- 2 SECTION 2. SECTION 812.1(A) AND (B) OF THE ACT, ADDED
- 3 OCTOBER 8, 1980 (P.L.785, NO.146), ARE AMENDED TO READ:
- 4 SECTION 812.1. ADMINISTRATION OF EXAMINATIONS.--
- 5 (A) ALL WRITTEN, ORAL, PRACTICAL, OR OTHER NONWRITTEN
- 6 EXAMINATIONS SHALL BE PREPARED AND ADMINISTERED BY A QUALIFIED
- 7 AND APPROVED PROFESSIONAL TESTING ORGANIZATION UNDER CONTRACT TO

- 8 THE APPROPRIATE BOARD OR COMMISSION WITHIN THE BUREAU OF
- 9 PROFESSIONAL AND OCCUPATIONAL AFFAIRS AND APPROVED BY THE
- 10 APPROPRIATE BOARD OR COMMISSION, EXCEPT THAT WHERE THE
- 11 PARTICULAR PROFESSIONAL AND OCCUPATIONAL STATUTES PERMIT THE USE
- 12 OF NATIONAL UNIFORM EXAMINATIONS AND/OR GRADING SERVICES, THESE
- 13 EXAMINATIONS AND GRADING SERVICES MAY CONTINUE TO BE USED. NO
- 14 BOARD OR COMMISSION MEMBER SHALL HAVE A FINANCIAL INTEREST IN A
- 15 PROFESSIONAL TESTING ORGANIZATION. [THIS SECTION]
- 16 NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE REQUIREMENTS OF
- 17 THIS SUBSECTION SHALL NOT APPLY TO ANY ORAL, PRACTICAL OR OTHER
- 18 NONWRITTEN EXAMINATION WHICH MAY BE REQUIRED BY A BOARD OR
- 19 COMMISSION UNTIL SUCH EXAMINATION IS AVAILABLE FROM A QUALIFIED
- 20 AND APPROVED PROFESSIONAL TESTING ORGANIZATION.
- 21 (B) EACH BOARD OR COMMISSION SHALL HAVE THE DISCRETIONARY
- 22 POWER TO CHARGE A FEE FOR THE ADMINISTRATION OF AND COST OF EACH
- 23 EXAMINATION. THE PURPOSE OF THIS FEE IS TO INSURE THAT THE
- 24 APPLICANTS' FEES COVER THE ENTIRE COST OF THE EXAMINATION. THIS
- 25 FEE SHALL BE IN ADDITION TO ANY FEE IMPOSED PURSUANT TO [THE ACT
- 26 OF JULY 1, 1978 (P.L.700, NO.124), KNOWN AS THE "BUREAU OF
- 27 PROFESSIONAL AND OCCUPATIONAL AFFAIRS FEE ACT."] ANY OTHER

- 2 SECTION 813. PUBLIC MEMBERS OF LICENSING BOARDS AND

- 4 (F) A PUBLIC MEMBER WHO FAILS TO ATTEND TWO CONSECUTIVE
- 5 CONFERENCES CONDUCTED PURSUANT TO SUBSECTION (E) SHALL FORFEIT
- 6 HIS SEAT ON THE BOARD OR COMMISSION OF WHICH HE IS A PUBLIC
- 7 MEMBER UNLESS THE COMMISSIONER OF PROFESSIONAL AND OCCUPATIONAL
- 8 AFFAIRS, UPON WRITTEN REQUEST FROM THE PUBLIC MEMBER, FINDS THAT
- 9 THE PUBLIC MEMBER SHOULD BE EXCUSED FROM A CONFERENCE BECAUSE OF
- 10 <u>ILLNESS OR THE DEATH OF A FAMILY MEMBER.</u>
