3 Section 15. Second or Subsequent Offense.--(a) Any person 4 convicted of a second or subsequent offense under clause (30) of 5 subsection (a) of section 13 of this act or of a similar offense 6 under any statute of the United States or of any state [may] 7 <u>shall</u> be imprisoned for a term up to twice the term otherwise 8 authorized, fined an amount up to twice that otherwise 9 authorized, or both.

10 (b) For purposes of this section, an offense is considered a 11 second or subsequent offense, if, prior to the commission of the 12 second offense, the offender has at any time been convicted 13 under clause (30) of subsection (a) of section 13 of this act or 14 of a similar offense under any statute of the United States or 15 of any state relating to controlled substances.

16 Section 2. This act shall take effect in 60 days.
