AN ACT

Amending the act of July 10, 1986 (P.L. , No.52A), entitled "A supplement to the act of April 1, 1863 (P.L.213, No.227), 2 entitled 'An act to accept the grant of Public Lands, by the 3 United States, to the several states, for the endowment of 4 5 Agricultural Colleges, 'making appropriations for carrying the same into effect; providing for a basis for payments of 7 such appropriations; and providing a method of accounting for 8 the funds appropriated, "increasing an appropriation to The Pennsylvania State University. 10 The General Assembly of the Commonwealth of Pennsylvania 11 hereby enacts as follows: 12 Section 1. Section 1 of the act of July 10, 1986 (P.L. - 1 Section 1. In order to carry into effect the act of
- 2 Congress, approved July 2, 1862, granting public land to the
- 3 several states for educational purposes, and subsequent acts of
- 4 Congress related thereto, and the act of the General Assembly of
- 5 Pennsylvania accepting the provisions and conditions of said
- 6 acts of Congress and pledging the faith of the State to carry
- 7 the same into effect, the following sums, or as much thereof as
- 8 may be necessary, are hereby appropriated to the Trustees of The
- 9 Pennsylvania State University for the fiscal year July 1, 1986,
- 10 to June 30, 1987, for the purposes and in the amounts as shown:
- 11 (1) For educational and general expenses and
- 12 for participation by a representative of the
- 13 institution, appointed by the chief executive
- 14 officer thereof, as a member of the Pennsylvania
- 15 Academic Commission on Technological Development,
- 16 a commission for interinstitutional communication
- 17 regarding technological innovation and development
- 18 and for dissemination of information on such
- 19 matters to the Pennsylvania business community and
- 20 others who may use such information for new
- 21 business and job development in Pennsylvania, such
- 22 commission to be composed of representatives of
- 23 every State-owned or State-related educational or
- 24 scientific institution receiving General Fund
- 25 assistance from the Commonwealth....[\$135,965,000] \$146,492,000
