## AN ACT

- 1 Amending the act of July 10, 1981 (P.L.214, No.67), entitled "An
- act relating to the lawful conduct of bingo, prescribing
- 3 penalties and making a repeal," further providing for the
- 4 operation and conducting of bingo.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 5(a) of the act of July 10, 1981
- 8 (P.L.214, No.67), known as the Bingo Law, amended December 15,
- 9 1982 (P.L.1299, No.293), is amended to read:
- 10 Section 5. Rules for licensing and operation.
- 11 (a) Issuance and fee. -- The licensing authority shall
- 12 license, upon application, any association as defined in section
- 13 3 to conduct the game of bingo only at one location in the
- 14 county, which shall, WHEN IN A COUNTY OF THE SECOND CLASS, SHALL <-
- 15 ONLY be in the municipality CITY, BOROUGH, INCORPORATED TOWN OR <-

- 1 TOWNSHIP where the main business office or headquarters of the
- 2 <u>association is located. The county treasurer OF A COUNTY OF THE</u>
- 3 <u>SECOND CLASS shall indicate on each license the municipality</u>
- 4 CITY, BOROUGH, INCORPORATED TOWN OR TOWNSHIP where the
- 5 <u>association may conduct bingo. The single municipal location</u>
- 6 <u>limitation shall not apply to a group of licensed associations</u>
- 7 conducting bingo at a central location. The license fee to be
- 8 charged to each nonprofit association shall be \$100 per annum
- 9 except to those recognized senior citizens' groups who conduct
- 10 bingo for their members only the fee shall be \$50 per annum. The
- 11 license fee to be charged to each agricultural association or
- 12 county fair shall be \$100 per annum. Associations which conduct
- 13 bingo only one period each year for not more than three
- 14 consecutive days shall be charged \$15 for the issuance of their
- 15 license. The fees collected pursuant to this section shall be
- 16 paid by the licensing authority into the general fund of the
- 17 county and used for county purposes. All records retained by the
- 18 licensing authority relating to the issuance of bingo licenses
- 19 and bingo permits shall be public information.

- 21 Section 2. This act shall take effect in 60 days.
