AN ACT

- 1 Amending the act of May 1, 1933 (P.L.103, No.69), entitled "An
- 2 act concerning townships of the second class; and amending,
- revising, consolidating, and changing the law relating
- 4 thereto, " further providing for police pension funds.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 595 of the act of May 1, 1933 (P.L.103,
- 8 No.69), known as The Second Class Township Code, reenacted and
- 9 amended July 10, 1947 (P.L.1481, No.567) and amended June 1,
- 10 1956 (1955 P.L.2021, No.677), is amended to read:
- 11 Section 595. Police Pension Fund. -- Where a police force is
- 12 being maintained, the township may, by ordinance, establish a
- 13 police pension fund or pension annuity into which each member of
- 14 the police force may be required to pay a member contribution of
- 15 an equal and proportionate monthly charge [not exceeding] which,
- 16 except to the extent that subsection (c) of section 607 of the
- 17 act of December 18, 1984 (P.L.1005, No.205), known as the
- 18 "Municipal Pension Plan Funding Standard and Recovery Act,"

- 1 applies, shall not exceed annually three per centum of the pay
- 2 of such member. The fund shall be under the direction of the
- 3 supervisors or such committee as they may, by ordinance,
- 4 prescribe for the benefit of such members of the police force as
- 5 shall receive honorable discharge therefrom by reason of age or
- 6 disability, and the families of such as may be injured or killed
- 7 in the service. Any allowances made to those who are retired by
- 8 reason of disability or age shall be in conformity with a
- 9 uniform scale.
- 10 Section 2. Section 598 of the act, added July 10, 1947
- 11 (P.L.1481, No.567), is amended to read:
- 12 Section 598. Township Appropriations; Gifts to Pension
- 13 Fund. -- Townships shall make contributions to the police pension
- 14 fund in an amount sufficient to meet the minimum obligation of
- 15 the municipality with respect to the pension plan pursuant to
- 16 the act of December 18, 1984 (P.L.1005, No.205), known as the
- 17 "Municipal Pension Plan Funding Standard and Recovery Act," and
- 18 may take by gift, grant, devise or bequest any money or
- 19 property, real, personal or mixed, in trust for the benefit of
- 20 such police pension fund. The care, management, investment and
- 21 disposal of such trust funds or property shall be vested in such
- 22 officers as the supervisors shall, by ordinance, direct, and
- 23 shall be governed by such officers subject to any directions,
- 24 not inconsistent therewith, as the donors of such funds and
- 25 property may prescribe.
- 26 Section 3. This act shall take effect immediately.
