AN ACT

- 1 Providing for the creation, operation and duties of the Vietnam
- 2 Veterans Health Initiative Commission as an advisory
- 3 commission to the Department of Health.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Vietnam
- 8 Veterans Health Initiative Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Commission." The Vietnam Veterans Health Initiative
- 14 Commission established pursuant to section 3.
- 15 "Department." The Department of Health of the Commonwealth.
- 16 "Veteran." A person who was a resident of this Commonwealth
- 17 at the time of his entry into the armed forces of the United

- 1 States or is a resident of this Commonwealth who served in the
- 2 armed forces during the years 1961-1975.
- 3 Section 3. Vietnam Veterans Health Initiative Commission.
- 4 (a) Establishment.--There is hereby created within the
- 5 department an advisory commission to be known as the Vietnam
- 6 Veterans Health Initiative Commission. This commission is to
- 7 obtain, study and disseminate information relating to health
- 8 issues pertinent to Vietnam veteran residents of this
- 9 Commonwealth.
- 10 (b) Membership.--The commission shall consist of 18 20
- 11 members. Members appointed by the Governor shall serve for an
- 12 initial term ending June 30, 1991. The Governor shall appoint
- 13 the Secretary of Health who shall serve as chairman, the
- 14 Secretary of Public Welfare and the Adjutant General who shall
- 15 serve as vice chairmen, the Chairman of the State Veterans'
- 16 Commission, the President of the Pennsylvania War Veterans
- 17 Council and 11 other members, of whom six shall be honorably
- 18 discharged veterans of the Vietnam conflict with at least one
- 19 veteran selected from each of the five geographical areas
- 20 covered by the Governor's Veterans Outreach and Assistance
- 21 Centers; at least one of these veterans shall be of the minority
- 22 race and one veteran shall be a female. Of the remaining members
- 23 to be appointed by the Governor, one shall be an epidemiologist,
- 24 one shall be a specialist in public health, one shall be a
- 25 clinical/medical specialist, one shall be a social service
- 26 specialist, and one shall be a mental health specialist. ; and
- 27 all of these remaining members shall be selected from an
- 28 academic institution in this Commonwealth. The Speaker of the
- 29 House of Representatives and the President pro tempore of the
- 30 Senate shall each appoint one member of his respective house TWO <

- 1 MEMBERS OF THEIR RESPECTIVE HOUSES, ONE FROM THE MAJORITY PARTY
- 2 AND ONE FROM THE MINORITY PARTY, to the commission who shall
- 3 serve during their respective terms of office.
- 4 (c) Vacancies.--Vacancies in membership of the commission
- 5 and its offices shall be filled for the unexpired term in the
- 6 same manner as the original appointment or election.
- 7 (d) Meetings.--The commission shall meet at least four times
- 8 a year at the call of the chairman. The initial meeting of the
- 9 commission shall be called by the chairman not later than August

- 11 (e) Sunset. The commission shall be established and
- 12 continue in existence until June 30, 1991.
- 13 (f) (E) Compensation and expenses. -- The members of the
- 14 commission shall receive no compensation for their services but
- 15 shall be allowed their actual and necessary expenses incurred in
- 16 the performance of their duties under this act.
- 17 Section 4. Powers and duties of the commission.
- 18 The commission shall have the following powers and duties:
- 19 (1) Determine what medical, administrative and social
- assistance is needed for veterans who may have suffered
- 21 adverse health effects as a result of their Vietnam service
- and submit its findings and recommendations to the General
- 23 Assembly for its consideration.
- 24 (2) Conduct an extensive outreach program which would
- coordinate and supplement the outreach efforts of the Federal
- 26 Government, the Department of Military Affairs, the State
- 27 Veterans' Commission, the Pennsylvania War Veterans Council,
- 28 county directors of veterans affairs, the Governor's Veterans
- 29 Outreach and Assistance Centers and all other organizations
- 30 to inform veterans who may have suffered adverse health

- 1 effects of any Federal or State assistance available to them.
- 2 (3) Assist the department in its duties as the official <--
- 3 agent of the Commonwealth for disseminating information to
- 4 Vietnam veterans and their dependents relating to health
- 5 studies which are being conducted by the Federal or State
- 6 governments.
- 7 Section 5. Cooperation with other agencies.
- 8 To the maximum extent feasible, the commission shall be
- 9 entitled to request and receive and shall utilize and be
- 10 provided with such facilities, resources and data of any court,
- 11 department, division, board, bureau, commission or agency of the
- 12 Commonwealth or any political subdivision thereof as it may
- 13 reasonably request to carry out properly its powers and duties
- 14 under this act. The release of otherwise confidential
- 15 information to the commission pursuant to this act shall be
- 16 deemed an official purpose of the Commonwealth and an exception
- 17 to laws providing for nondisclosure.
- 18 Section 6. Information to be confidential.
- 19 The commission shall not disclose information received
- 20 pursuant to this act so as to divulge the identities of the
- 21 persons to whom it relates except as is necessary to carry out
- 22 the purposes of this act.
- 23 Section 7. Duties of department.
- 24 The department shall, in coordination with the Department of
- 25 Public Welfare:
- 26 (1) Maintain a central data bank within the department
- 27 for information collected on the health effects of exposure
- 28 to Vietnam herbicides and for the cataloging of existing
- 29 scientific and medical effects of the exposure.
- 30 (2) Establish a reporting process for veterans who have

- 1 indicated they have suffered adverse health, medical and
- 2 mental effects as a result of their Vietnam service.
- 3 (3) Establish a continuing education program for all
- 4 health professionals to assist them in understanding the
- 5 potential risks and state-of-the-art knowledge with regard to
- 6 detection, diagnosis and treatment of acute and chronic
- 7 symptoms associated with Vietnam service.
- 8 (4) At the request of the commission, initiate studies
- 9 on the health effects of Vietnam service.
- 10 (5) Act as the official agent of the Commonwealth for
- 11 disseminating information to Vietnam veterans and their
- 12 dependents relating to health studies which are being
- conducted by the Federal or State Government.
- 14 Section 8. Reports to the Department of Health and the
- Department of Public Welfare.
- 16 (a) Voluntary reports.--A physician or mental health
- 17 specialist who has primary responsibility for treating or
- 18 assisting a veteran who may have suffered adverse health effects
- 19 as a result of Vietnam service shall, at the request of the
- 20 veteran, submit a report to the department on a form provided by
- 21 the department. If there is no physician or mental health
- 22 specialist having primary responsibility for treating the
- 23 veteran, the hospital or facility providing treatment shall, at
- 24 the request of the veteran, submit the report.
- 25 (b) Additional information. -- The department may require the
- 26 veteran to provide such other information as determined by the
- 27 secretary of the department.
- 28 Section 9. Cooperation with commission.
- The commission may request and shall receive from any
- 30 department, division, board, bureau, commission or agency of the

- 1 Commonwealth or of any political subdivision thereof such
- 2 assistance and data as will enable it to properly carry out the
- 3 activities and effectuate the purposes of this act. The
- 4 commission may also enter into any contract for services as it
- 5 deems necessary with a private agency or concern, or any
- 6 academic institution, upon said terms and conditions as it deems
- 7 appropriate. Information concerning patient and medical data
- 8 provided to the commission pursuant to this section shall be
- 9 kept confidential according to these provisions. Statistical
- 10 information collected under this act is public information.
- 11 Section 10. Immunity from liability.
- 12 A physician, mental health specialist or hospital subject to
- 13 this act who complies with this act may not be held civilly or
- 14 criminally liable for providing the information required by this
- 15 act.
- 16 Section 11. Report by commission.
- 17 The commission shall make an annual report to the General
- 18 Assembly on the health status of Pennsylvania Vietnam veterans
- 19 with recommendations concerning the effectiveness, impact and
- 20 benefits derived from the special policies as provided for in
- 21 this act. THIS REPORT SHALL INCLUDE COMPLETE INFORMATION ON THE
- 22 OPERATION OF THE COMMISSION. The report shall be delivered on or
- 23 before September 1 and shall contain evaluations of the policies
- 24 and any legislation deemed necessary and proper to the House
- 25 Federal-State Relations and Military and Veterans Affairs
- 26 Committees and the Senate Military and Veterans Affairs
- 27 Committee.
- 28 Section 12. Transfer of records.
- 29 All records of the Vietnam Herbicides Information Commission
- 30 shall be transferred to the Vietnam Veterans Health Initiative

- 1 Commission.
- 2 Section 13. Repeal.
- 3 The act of April 29, 1982 (P.L.355, No.99), known as the
- 4 Vietnam Herbicides Information Act, is repealed.
- 5 SECTION 14. EXPIRATION OF ACT.
- 6 THIS ACT SHALL EXPIRE THREE YEARS FROM THE EFFECTIVE DATE OF

- 8 Section 14 15. Effective date.
- 9 This act shall take effect July 1, 1987, or immediately,
