### AN ACT

1 2 3	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing for antique and classic motor vehicles; and providing for collector motor vehicles.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
б	Section 1. The definitions of "antique motor vehicle" and
7	"classic motor vehicle" in section 102 of Title 75 of the
8	Pennsylvania Consolidated Statutes are amended and the section
9	is amended by adding a definition to read:
10	§ 102. Definitions.
11	Subject to additional definitions contained in subsequent
12	provisions of this title which are applicable to specific
13	provisions of this title, the following words and phrases when
14	used in this title shall have, unless the context clearly
15	indicates otherwise, the meanings given to them in this section:
16	* * *
17	"Antique motor vehicle." A motor vehicle, but not a

18 reproduction thereof, manufactured more than 25 years prior to

the current year which has been maintained in or restored to a
 condition which is substantially in conformance with
 manufacturer specifications <u>and appearance</u>.

"Classic motor vehicle." A [self-propelled] motor vehicle, 5 but not a reproduction thereof, [manufactured more than ten 6 years prior to the current year and, because of discontinued 7 production and limited availability, determined by the 8 department to be a model or make of significant value to 9 10 collectors or exhibitors and] which is included on the list of 11 milestone or classic cars published by the Milestone Car Society or the Classic Car Club of America and has been maintained in or 12 13 restored to a condition which is substantially in conformity 14 with manufacturer specifications and appearance. Any classic 15 motor vehicle registered under section 1340 (relating to antique 16 and classic plates) which no longer qualifies as a classic motor 17 vehicle under these provisions may retain a classic registration 18 as of the effective date of this act unless another type of registration is applied for and issued for the vehicle. 19 20 "Collector motor vehicle." A motor vehicle, but not a reproduction thereof, manufactured more than ten years prior to 21 22 the current year, which has been maintained in or restored to a 23 condition which is substantially in conformity with manufacturer 24 specifications and appearance.

26 Section 2. Section 1340 of Title 75 is amended to read:
27 § 1340. Antique and classic plates.

(a) General rule.--Upon submission by a vehicle owner of
information satisfactory to the department that a motor vehicle
is an antique motor vehicle or classic motor vehicle,

accompanied by the appropriate fee, the department may issue 1 special plates for the vehicle. [No annual registration fee may 2 3 be charged for antique or classic motor vehicles.] 4 (b) Use of plates.--It is unlawful for any person to operate 5 a vehicle with antique or classic registration plates for general daily transportation. Permitted use shall be limited to 6 participation in club activities, exhibits, tours, parades, 7 occasional transportation and similar uses. Occasional 8 9 transportation shall mean no more than one day per week. 10 (c) Additional provisions.--(1) Antique vehicles and classic vehicles are exempt 11 12 from Chapter 43 (relating to lighting equipment) and 13 Subchapter A of Chapter 47 (relating to inspection 14 requirements). 15 (2) Any registered antique vehicle or classic vehicle 16 may bear an original Pennsylvania registration plate of the year of issue corresponding to the year of manufacture of the 17 18 registered vehicle. A clear photograph of the plate must be submitted together with the application for registration. The 19 20 registered plate must remain in the vehicle at all times. Section 3. Title 75 is amended by adding sections to read: 21 § 1348. Collector plate. 22 Upon submission by a vehicle owner of information 23 24 satisfactory to the department that a motor vehicle is a 25 collector motor vehicle, accompanied by the appropriate fee, the 26 department may issue a special collector plate for the vehicle, which shall have the same force and effect as a regular 27 28 registration plate. § 1933. Collector motor vehicles. 29 30 The fee for issuance of a collector motor vehicle plate shall

1	be \$20 which shall be in addition to the annual registration fee
2	appropriate for the vehicle type. The issuance fee shall be
3	charged for each collector vehicle registration plate issued or
4	replaced.
