## AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled 2 "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 6 7 Teachers Colleges; abolishing, creating, reorganizing or 8 authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and 9 10 duties of the Governor and other executive and administrative officers, and of the several administrative departments, 11 12 boards, commissions, and officers; fixing the salaries of the 13 Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of 14 15 certain administrative officers, and of all deputies and 16 other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the 17 18 number and compensation of the deputies and all other 19 assistants and employes of certain departments, boards and 20 commissions shall be determined, " changing the Department of Public Welfare to the Department of Human Services; 21 22 ESTABLISHING THE STATE BOARD OF HUMAN SERVICES; and making 23 related substantive and editorial changes.

24 The General Assembly of the Commonwealth of Pennsylvania

- 24 Pennsylvania Securities Commission.

- 29 Board and to the Pennsylvania State Police.

- 15 Nine (9) members of the board shall constitute a quorum. A
- 16 chairman who shall not be a member of an advisory committee
- 17 shall be elected by the board, annually, from among its members.
- 18 Members of the board shall serve without compensation other than
- 19 reimbursement of travel and other actual expenses incurred in
- 20 the performance of their duties. The board shall meet at least
- 21 six (6) times a year. Special meetings of the board shall be
- 22 held on call of the chairman or the Secretary of [Public
- 23 Welfare] Human Services, and it shall be the duty of the
- 24 chairman to call a special meeting upon the written request of
- 25 one third (1/3) or more members, not including vacancies, of the
- 26 board.

- 23 NINE (9) MEMBERS OF THE BOARD SHALL CONSTITUTE A QUORUM. A
- 24 CHAIRMAN WHO SHALL NOT BE A MEMBER OF AN ADVISORY COMMITTEE
- 25 SHALL BE ELECTED BY THE BOARD, ANNUALLY, FROM AMONG ITS MEMBERS.
- 26 MEMBERS OF THE BOARD SHALL SERVE WITHOUT COMPENSATION OTHER THAN
- 27 REIMBURSEMENT OF TRAVEL AND OTHER ACTUAL EXPENSES INCURRED IN
- 28 THE PERFORMANCE OF THEIR DUTIES. THE BOARD SHALL MEET AT LEAST
- 29 SIX (6) TIMES A YEAR. SPECIAL MEETINGS OF THE BOARD SHALL BE
- 30 HELD ON CALL OF THE CHAIRMAN OR THE SECRETARY OF HUMAN SERVICES,

- 1 AND IT SHALL BE THE DUTY OF THE CHAIRMAN TO CALL A SPECIAL
- 2 MEETING UPON THE WRITTEN REQUEST OF ONE-THIRD (1/3) OR MORE
- 3 <u>MEMBERS, NOT INCLUDING VACANCIES, OF THE BOARD.</u>
- 4 (1) The following advisory committees are hereby created:
- 5 Advisory Committee for the Blind,
- 6 Advisory Committee for General and Special Hospitals,
- 7 Advisory Committee for Children and Youth,
- 8 Advisory Committee for Public Assistance,
- 9 Advisory Committee for Mental Health and Mental Retardation.
- 10 Each advisory committee shall consist of the Commissioner in
- 11 the Department of [Public Welfare] <u>Human Services</u>, directing the
- 12 program to which the advisory committee is attached, as an ex
- 13 officio member, and not less than three (3) nor more than nine
- 14 (9) members appointed by the Governor. In the case of the
- 15 Advisory Committee for Mental Health and Mental Retardation, the
- 16 committee shall include the Chairman of the Public Health and
- 17 Welfare Committee of the Senate, the Chairman of the Health and
- 18 Welfare Committee of the House of Representatives and the
- 19 President of the Pennsylvania State Association of County
- 20 Commissioners or his alternate. The exact number of members of
- 21 each advisory committee shall be determined by the Governor
- 22 [upon recommendation of the State Board of +Public Welfare]
- 23 <u>Human Services</u>. The qualifications of the members of each
- 24 advisory committee shall [also] be determined by the Governor
- 25 [upon recommendation of the State Board of {Public Welfare}]
- 26 <u>Human Services</u>: Provided, That with respect to each advisory <---

- 27 committee, the Governor shall appoint members with due regard
- 28 for representation of the professional and lay groups concerned
- 29 with the fields of interest served by the program to which each
- 30 advisory committee is attached. The term of office of each

- 1 member of each advisory committee, except as herein otherwise
- 2 provided, shall be six (6) years.
- 3 The original appointment of the members of the advisory
- 4 committee shall be for overlapping terms of six (6), four (4)
- 5 and two (2) years. In making these original appointments, the
- 6 Governor shall, in so far as possible, appoint approximately
- 7 one-third (1/3) of the recommended complement of each advisory
- 8 board to each of the overlapping terms.
- 9 A majority of the members of each advisory committee shall
- 10 constitute a quorum. Each advisory committee shall elect a
- 11 chairman from among its members. Each advisory committee shall
- 12 meet at least four (4) times a year. Special meetings of each
- 13 advisory committee shall be held on call of the chairman, and it
- 14 shall be the duty of the chairman to call a special meeting upon
- 15 the written request of one-third (1/3) or more of the members
- 16 not including vacancies of the advisory committee.
- 17 [The provisions of clause (k) of this section with respect to <---
- 18 filling of vacancies, removal of members, length of service,
- 19 political party office and compensation shall be applicable to
- 20 advisory committee members, and are incorporated herein by
- 21 reference.] ANY VACANCY OCCURRING IN THE MEMBERSHIP OF AN
