| 10 | Section 1. Section 1 of the act of June 24, 1976 (P.L.424, |

14 Section 1. In the event a law enforcement officer, ambulance

service or rescue squad member or firefighter is killed in the 1 performance of his duties, such political subdivision within 30 2 3 days from the date of death shall submit certification of such 4 death to the Commonwealth. A volunteer firefighter shall be 5 deemed to be acting in the performance of his duties for the purposes of this act going to or directly returning from a fire 6 7 which the fire company or fire department attended including 8 travel from and direct return to a firefighter's home, place of 9 business or other place where he or she shall have been when he 10 or she received the call or alarm or while participating in 11 instruction fire drills in which the fire department or fire company shall have participated or while repairing or doing 12 13 other work about or on the fire apparatus or buildings and 14 grounds of the fire company or fire department upon the 15 authorization of the chief of the fire company or fire 16 department or other person in charge or while answering any 17 emergency calls for any purpose or while riding upon the fire 18 apparatus which is owned or used by the fire company or fire 19 department or while performing any other duties of such fire 20 company or fire department as authorized by the municipality or 21 while performing duties imposed by section 15, act of April 27, 22 1927 (P.L.465, No.299), referred to as the Fire and Panic Act. A 23 volunteer ambulance service or rescue squad member shall be 24 deemed to be acting in the performance of his duties for the 25 purposes of this act going to or directly returning from an 26 emergency which the ambulance service or rescue squad attended 27 including travel from and direct return to an ambulance service 28 or rescue squad member's home, place of business or other place where he or she shall have been when he or she received the call 29 30 or alarm or while participating in drills in which the ambulance - 2 -19870H1332B1536

service or rescue squad shall have participated or while 1 repairing or doing other work about or on any emergency vehicle 2 3 or buildings and grounds of the ambulance service or rescue 4 squad upon the authorization of the chief of the ambulance 5 service or rescue squad or other person in charge while answering any emergency calls for any purpose or while riding 6 7 upon any vehicles which are owned or used by the ambulance 8 service or rescue squad. Upon receipt of such certification, the 9 Commonwealth shall, from moneys payable out of the General Fund, 10 pay to the political subdivision the sum of [\$25,000] \$50,000. 11 Within five days of receipt of said sum from the Commonwealth, the political subdivision shall pay such sum as a benefit to the 12 13 surviving spouse, or if there is no surviving spouse, to the minor children of the firefighter, ambulance service or rescue 14 15 squad member or law enforcement officer killed in the 16 performance of duty. When no spouse or minor children survive, 17 the benefit shall be paid to the parent or parents or designee 18 of such firefighter, ambulance service or rescue squad member or 19 law enforcement officer.

20 The Commonwealth of Pennsylvania shall pay out of the General Fund to the surviving spouse, or, if there is no surviving 21 22 spouse, the minor children of a State police officer or other 23 law enforcement officer of the Commonwealth killed in the performance of his duties the sum of [\$25,000] \$50,000. When no 24 25 spouse or minor children survive, the benefit shall be paid to 26 the parent or parents or designee of such State police officer or other law enforcement officer of the Commonwealth. The 27 28 benefit shall be payable whether or not the officer was killed 29 within the Commonwealth of Pennsylvania.

30 Section 2. This act shall take effect immediately.
