AN ACT

- Amending the act of December 7, 1982 (P.L.784, No.225), entitled "An act relating to dogs, regulating the keeping of dogs; 3 providing for the licensing of dogs and kennels; providing for the protection of dogs and the detention and destruction 5 of dogs in certain cases; regulating the sale and 6 transportation of dogs; declaring dogs to be personal property and the subject of theft; providing for the 7 8 assessment of damages done to livestock, poultry and domestic game birds; providing for payment of damages by the 9 Commonwealth in certain cases and the liability of the owner 10 11 or keeper of dogs for such damages; imposing powers and 12 duties on certain State and local officers and employees; providing penalties; and creating a Dog Law Restricted 13 14 Account, " further providing for service fees AND GRANTS FOR JOINT MUNICIPAL DOG LAW ENFORCEMENT AGENCIES; AND PROVIDING 15 16 FOR DAMAGES CAUSED BY COYOTES. 17 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 18 19 Section 1. Section 204 SECTIONS 204 AND 705 of the act of 20 December 7, 1982 (P.L.784, No.225), known as the Dog Law, is ARE 21 amended to read: Section 204. Who shall issue licenses; fees; records.
- 23 The county treasurer may authorize agents to process

- 1 applications for dog license certificates and to issue license
- 2 certificates and tags. The county treasurer shall establish the
- 3 bonding requirements for all agents designated for purposes of
- 4 this section, except for district justices who when authorized
- 5 by the county treasurer shall not be required to furnish a bond.
- 6 All persons designated by the county treasurer under this
- 7 section shall charge [75ç] <u>\$1</u> as a service fee for each
- 8 application processed in addition to the license fees
- 9 established under section 201. The agent shall retain [25¢] 50¢
- 10 of this service fee and the county treasurer shall retain 50¢ of
- 11 the service fee for the use of the county except when the agent
- 12 is a district justice, when the entire service fee shall be
- 13 remitted to the county treasurer for the use of the county. All
- 14 records of applications by agents designated by the county
- 15 treasurer under this section shall be forwarded to the county
- 16 treasurer who shall maintain all dog license application records
- 17 for the county.
- 18 SECTION 705. HARBORING UNLICENSED DOGS; FORFEITURE OF RIGHTS OF
- 19 REIMBURSEMENT.
- 20 ANY PERSON WHO OWNS OR HARBORS AN UNLICENSED DOG REQUIRED TO
- 21 BE LICENSED UNDER THIS ACT[,] SHALL FORFEIT ANY RIGHT TO BE
- 22 REIMBURSED BY THE DEPARTMENT FOR ANY DAMAGES TO HIS LIVESTOCK,
- 23 POULTRY OR DOMESTIC GAME BIRDS BY DOGS OR COYOTES.
- 24 SECTION 2. THE ACT IS AMENDED BY ADDING A SECTION TO READ:

- 25 <u>SECTION 706. DAMAGES CAUSED BY COYOTES; COMPLAINTS; LIABILITY.</u>
- 26 (A) GENERAL RULE. -- WHENEVER ANY PERSON SUSTAINS ANY LOSS BY
- 27 COYOTE TO LIVESTOCK OR POULTRY, OR TO GAME BIRDS RAISED IN
- 28 CAPTIVITY, AND WHILE CONFINED WITHIN A FIELD OR OTHER ENCLOSURE,
- 29 PROVIDED THAT THE ENCLOSURE IS ADEQUATE FOR THE PURPOSE
- 30 INTENDED, SUCH PERSON OR HIS AGENT OR ATTORNEY MAY, IMMEDIATELY

- 1 AFTER THE DAMAGE WAS DONE, COMPLAIN TO A STATE DOG WARDEN OR
- 2 EMPLOYEE OF THE DEPARTMENT AND MAY MAKE APPLICATION TO THE
- 3 DEPARTMENT FOR REIMBURSEMENT OF SUCH LOSS OR DAMAGE. THE
- 4 COMPLAINT SHALL BE IN WRITING, SHALL BE SIGNED BY THE PERSON
- 5 MAKING THE COMPLAINT AND SHALL STATE WHEN, WHERE AND HOW THE
- 6 DAMAGE WAS DONE. UPON RECEIPT OF SUCH NOTICE, THE STATE DOG
- 7 WARDEN SHALL AT ONCE EXAMINE THE PLACE WHERE THE ALLEGED LOSS
- 8 WAS SUSTAINED AND THE LIVESTOCK OR POULTRY OR DOMESTIC GAME BIRD
- 9 INJURED OR KILLED. THE STATE DOG WARDEN MAY EXAMINE UNDER OATH
- 10 OR AFFIRMATION ANY WITNESS CALLED BEFORE HIM. AFTER MAKING
- 11 <u>DILIGENT INQUIRY IN RELATION TO SUCH CLAIM, THE INVESTIGATING</u>
- 12 OFFICER SHALL DETERMINE WHETHER ANY DAMAGE HAS BEEN SUSTAINED
- 13 AND THE AMOUNT OF THE DAMAGE. IF THE OWNER OF THE LIVESTOCK OR
- 14 POULTRY OR DOMESTIC GAME BIRD DOES NOT AGREE AS TO THE AMOUNT OF
- 15 DAMAGE ALLOWED BY THE APPRAISER, THE OWNER REQUESTING THE
- 16 APPRAISAL AND THE APPRAISER MAY APPOINT A DISINTERESTED
- 17 QUALIFIED CITIZEN TO ASSIST IN DETERMINING THE AMOUNT OF DAMAGE
- 18 SUSTAINED. FOR SUCH SERVICES, THE SAID DISINTERESTED CITIZEN
- 19 SHALL RECEIVE APPROPRIATE COMPENSATION WHICH SHALL BE PAID BY
- 20 THE OWNER REQUESTING THE APPRAISAL. THERE SHALL BE A MAXIMUM
- 21 <u>ALLOWABLE CLAIM LOSS ON EACH OCCURRENCE OF \$10,000 PER ANIMAL;</u>
- 22 HOWEVER, IN NO INSTANCE SHALL THE PAYMENT EXCEED 90% OF THE
- 23 APPRAISED VALUE. ALL CLAIMS SHALL BE PAID FROM THE DOG LAW
- 24 RESTRICTED ACCOUNT; HOWEVER, IN NO INSTANCE SHALL THE SUM TOTAL
- 25 OF PAID CLAIMS FOR THE PURPOSE OF THIS SECTION EXCEED \$20,000
- 26 PER ANNUM. THE SECRETARY SHALL HAVE THE POWER TO PROMULGATE SUCH
- 27 RULES AND REGULATIONS AS MAY BE NECESSARY TO IMPLEMENT THIS
- 28 SECTION.
- 29 (B) DEFINITION. -- AS USED IN THIS SECTION, THE TERM "COYOTE"
- 30 MEANS THE GENUS AND SPECIES KNOWN AS CANIS LATRANS.

- 1 SECTION 3. SECTION 1002(A) OF THE ACT IS AMENDED TO READ:
- SECTION 1002. COUNTY DOG LAW PROGRAMS. 2
- 3 (A) DOG CONTROL FACILITIES. -- ANY COUNTY EXCEPT COUNTIES OF
- 4 THE FIRST CLASS OR ANY INCORPORATED HUMANE ORGANIZATION MAY
- SUBMIT REQUESTS FOR FUNDING TO ESTABLISH AND MAINTAIN DOG 5
- 6 CONTROL FACILITIES OR OTHER FUNCTIONS OF DOG CONTROL WITHIN THE
- 7 COUNTY TO COMPLEMENT THE COMMONWEALTH DOG LAW ENFORCEMENT
- PROGRAM. IF THREE OR MORE MUNICIPALITIES JOIN TO FORM ONE DOG
- LAW ENFORCEMENT AGENCY, THE JOINT AGENCY SHALL BE ELIGIBLE FOR
- 10 50% OF THE TOTAL GRANT MONEYS THAT THE MUNICIPALITIES WOULD BE
- 11 ENTITLED TO IF EACH APPLIED INDIVIDUALLY, WITHOUT THE CURRENT
- 12 RESTRICTIONS IMPOSED BY THE REGULATIONS OF THE DEPARTMENT
- 13 REGARDING THE USAGE OF THE MONEYS. IF A JOINT DOG LAW
- 14 ENFORCEMENT AGENCY IS CREATED, ONE OF THE MUNICIPALITIES SHALL
- 15 ACT AS A LEAD AGENCY FOR THE PURPOSES OF MEETING THE
- 16 REQUIREMENTS OF THE PROGRAM, INCLUDING, BUT NOT LIMITED TO,
- 17 RECORDKEEPING, SUPERVISION OF EMPLOYEES AND OTHER ADMINISTRATIVE
- 18 DUTIES AS REQUIRED BY THIS ACT.

- 20 Section 2-3 4. This act shall take effect in 60 days.
