## AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated  
2 Statutes, further providing for display of registration  
3 plate; AND EXEMPTING CERTAIN VEHICLES FROM THE CATASTROPHIC <—  
4 LOSS TRUST FUND CHARGE.

5 The General Assembly of the Commonwealth of Pennsylvania  
6 hereby enacts as follows:

7 Section 1. Section 1332 of Title 75 of the Pennsylvania  
8 Consolidated Statutes is amended by adding a subsection to read:  
9 § 1332. Display of registration plate.

11 (c) Organ donor designation.--A sticker may be affixed to  
12 the lower right-hand corner of the registration plate, in such a  
13 manner as not to obscure the registration number, to indicate  
14 that the vehicle is registered to an organ donor.

15 SECTION 2. SECTION 1762 OF TITLE 75 IS AMENDED TO READ: <—  
16 § 1762. FUNDING.

17 THE CATASTROPHIC LOSS TRUST FUND SHALL BE FUNDED BY LEVYING

1 AN INITIAL CHARGE OF \$5 UPON ALL MOTOR VEHICLES REQUIRED TO BE  
2 REGISTERED UNDER CHAPTER 13 (RELATING TO REGISTRATION OF  
3 VEHICLES) EXCEPT TRAILERS, RECREATIONAL VEHICLES NOT INTENDED  
4 FOR HIGHWAY USE, MOTORCYCLES, MOTOR-DRIVEN CYCLES, MOTORIZED  
5 PEDALCYCLES, ANTIQUE MOTOR VEHICLES, CLASSIC MOTOR VEHICLES OR  
6 LIKE TYPE VEHICLES. THIS CHARGE SHALL BE REMITTED TO AN  
7 INSURANCE COMPANY OR OTHER PARTY AS MAY BE DESIGNATED BY THE  
8 INSURANCE DEPARTMENT. UPON RECEIPT OF THE CHARGE, THE INSURANCE  
9 COMPANY OR OTHER DESIGNATED PARTY SHALL REMIT IT TO THE  
10 INSURANCE DEPARTMENT FOR DEPOSIT IN THE TRUST FUND. THE  
11 CATASTROPHIC LOSS TRUST FUND BOARD SHALL, BY REGULATION,  
12 DETERMINE BY JANUARY 1 OF EACH CALENDAR YEAR THE AMOUNT OF THE  
13 FUND CHARGE FOR EACH REGISTRATION YEAR SUBSEQUENT TO THE INITIAL  
14 REGISTRATION YEAR AND SHALL NOTIFY THE INSURANCE DEPARTMENT  
15 WHICH SHALL NOTIFY THE INSURANCE COMPANIES OR OTHER DESIGNATED  
16 PARTIES TO COLLECT THE CHARGE.

17 Section 2 3. This act shall take effect in 60 days.
