20	commissions shall be determined, " imposing additional powers
21	and duties on the Department of Transportation relating to
22	the inspection of certain bridges without regard to ownership
23	and directing the State Treasurer to make certain deductions
24	from county liquid fuel tax allocations.

27	(19) To compile, maintain and forward to the Federal Highway	
28	Administration data on all bridges in the Commonwealth carrying	
29	public highways which are twenty or more feet in length, without	
30	regard to ownership. In carrying out this duty, the department

1	is authorized to and directed to inspect those bridges owned by
2	municipalities and counties which do not conduct the required
3	biennial inspection, to post the inspected bridges with the
4	required information and to collect all nonreimbursed costs from
5	those municipalities and counties by withholding that
6	municipality's portion of its liquid fuels tax allocation or, in
7	the case of counties, receiving funds withheld under section
8	<u>1105.</u>

10	Section 3. This act shall take effect immediately.
