## AN ACT

1 Making an appropriation to ~~the Philadelphia~~ THE University of <—  
2 the Arts, Philadelphia.

3 The General Assembly of the Commonwealth of Pennsylvania  
4 hereby enacts as follows:

5 Section 1. The sum of ~~\$841,000~~ \$1,047,000 is hereby <—  
6 appropriated to ~~the Philadelphia~~ THE University of the Arts, <—  
7 Philadelphia, for the fiscal year July 1, 1988, to June 30,  
8 1989, for instruction and student aid. THE APPROPRIATED AMOUNT <—  
9 INCLUDES A ONE-TIME GRANT OF \$206,000. The ~~Philadelphia~~ <—  
10 University of the Arts consists of the institutions formerly  
11 known as the Philadelphia Colleges of the Arts and the  
12 Philadelphia College of Performing Arts.

13 Section 2. Payments to ~~the Philadelphia~~ THE University of <—  
14 the Arts on account of the appropriation provided in section 1  
15 shall be made by the Secretary of Education in equal quarterly  
16 payments.

17 Section 3. The ~~Philadelphia~~ University of the Arts shall <—

1 provide such information as may be necessary to carry out the  
2 provisions of this act and in such form and manner as the  
3 Department of Education shall prescribe.

4 Section 4. The ~~Philadelphia~~ University of the Arts shall <—  
5 report its revenues and expenditures and present its financial  
6 statement in accordance with generally accepted accounting  
7 principles and procedures for educational institutions as set  
8 forth in the "Higher Education Finance Manual (1975)" and the  
9 "Commonwealth of Pennsylvania Budget Instructions for the State  
10 System of Higher Education, State-Related Universities and Non-  
11 State-Related Colleges and Universities."

12 SECTION 5. ALL SUMS OF MONEY PAID TO THE UNIVERSITY OF THE <—  
13 ARTS PURSUANT TO THE ACT OF JULY 13, 1988 (P.L. , NO.26A),  
14 ENTITLED "AN ACT MAKING AN APPROPRIATION TO THE PHILADELPHIA  
15 UNIVERSITY OF THE ARTS, PHILADELPHIA," SHALL BE CREDITED TOWARD  
16 AND DEDUCTED FROM THE AMOUNT APPROPRIATED IN THIS ACT.

17 SECTION 6. THE ACT OF JULY 13, 1988 (P.L. , NO.26A),  
18 ENTITLED "AN ACT MAKING AN APPROPRIATION TO THE PHILADELPHIA  
19 UNIVERSITY OF THE ARTS, PHILADELPHIA," IS REPEALED.

20 Section ~~5~~ 7. This act shall take effect July 1, 1988, or <—  
21 immediately, whichever is later.
