5 (b) It is the intent of the General Assembly that the filled complement level of workmen's compensation referees be increased 6 7 to at least 55 and that sufficient support personnel be provided 8 for the referees so that the time for consideration of contested workmen's compensation cases is reduced and the present backlog 9 10 of cases are brought to decision. 11 Section 2. This act shall take effect July 1, 1987, or immediately, whichever is later. 12 13 SECTION 1.
