## AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public
- welfare laws of the Commonwealth," providing for training for
- 4 family day-care providers.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The act of June 13, 1967 (P.L.31, No.21), known
- 8 as the Public Welfare Code, is amended by adding a section to
- 9 read:
- 10 Section 212. Training for Family Day Care Providers. -- (A)
- 11 The department shall arrange for training for prospective and
- 12 current family day care providers. The training shall cover, at
- 13 <u>a minimum</u>, the following areas, as they relate to child care:
- (1) First aid and basic safety, RESULTING IN CERTIFICATION <
- 15 IN STANDARD FIRST AID AND COMMUNITY CARDIOPULMONARY

- 1 RESUSCITATION.
- 2 (2) Child development, including information on
- 3 characteristics of infants and preschool and school-age children
- 4 that can assist caregivers in nurturing the physical, social,
- 5 <u>emotional and intellectual growth of each child.</u>
- 6 (3) Nutrition, including the Child Care Food Program
- 7 sponsored by the Federal Department of Agriculture.
- 8 (4) Health care and hygiene, including washing hands before
- 9 <u>handling food, care of diapers and toilet areas.</u>
- 10 (5) Small business management skills, including budgets and
- 11 <u>recordkeeping</u>.
- 12 (6) Discipline and guidance of children.
- 13 (7) Creative programming and development of proper learning
- 14 environments for children.
- 15 (8) Utilization of community resources.
- 16 (9) Development of communication skills of caregivers with
- 17 parents and families.
- 18 (B) THE DEPARTMENT SHALL ENCOURAGE BUT NOT REQUIRE FAMILY
- 19 DAY CARE PROVIDERS TO PARTICIPATE IN THE TRAINING MADE AVAILABLE
