AN ACT

- Amending the act of June 24, 1937 (P.L.2045, No.397), entitled, 2 as amended, "An act relating to the support of indigent 3 persons; providing for the support of such persons by certain relatives, and for the recovery of public moneys expended for 5 care and assistance from the property and estates of certain persons; providing for guardians of the person and property 7 of such persons; providing for the arrest and seizure and sale of the property of deserters; and providing procedure," 8 9 providing that no lien shall be imposed against the real property of persons receiving assistance. 10
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. Section 4 of the act of June 24, 1937 (P.L.2045,
- 14 No.397), known as The Support Law, amended August 22, 1961
- 15 (P.L.1029, No.464), July 26, 1963 (P.L.318, No.172) and August

- 1 13, 1963 (P.L.682, No.361), is amended to read:
- 2 Section 4. Property of Persons Liable for Expenses Incurred
- 3 for Support and Assistance. -- (a) Except as limited by
- 4 subsection (c) hereof, the real and personal property of any
- 5 person shall be liable for the expenses of his support,
- 6 maintenance, assistance and burial, and for the expenses of the
- 7 support, maintenance, assistance and burial of the spouse and
- 8 unemancipated minor children of such property owner, incurred by
- 9 any public body or public agency, if such property was owned
- 10 during the time such expenses were incurred, or if a right or
- 11 cause of action existed during the time such expenses were
- 12 incurred from which the ownership of such property resulted. Any
- 13 public body or public agency may sue the owner of such property
- 14 for moneys so expended, and any judgment obtained shall be a
- 15 lien upon the said real estate of such person and be collected
- 16 as other judgments, except as to the real and personal property
- 17 comprising the [home] primary residence and furnishings of such
- 18 person, which [home] primary residence shall not be subject to
- 19 the lien of such judgment [but] and shall not be subject to
- 20 execution on such judgment during the lifetime of the person,
- 21 surviving spouse, or dependent children.
- 22 (b) Except as limited by subsection (c) hereof, any claim
- 23 for the expenses of support, maintenance, assistance and burial
- 24 of a person and for the support, maintenance, assistance and
- 25 burial of his spouse and unemancipated minor children, held by
- 26 any public body or public agency, shall have the same force and
- 27 effect against the real and personal estate of a deceased person
- 28 as other debts of a decedent, and shall be ascertained and
- 29 recovered in the same manner.
- 30 (c) No lien may be imposed against the property which is the

- 1 primary residence of any individual or of his spouse on account
- 2 of medical assistance for the aged paid or to be paid on his
- 3 behalf (except pursuant to the judgment of a court on account of
- 4 benefits incorrectly paid on behalf of such individual), and
- 5 there shall be no adjustment or recovery from such individual's
- 6 estate or from the estate of his spouse of any medical
- 7 assistance for the aged correctly paid on behalf of such
- 8 individual.
- 9 Section 2. On and after the effective date of this act, all
- 10 real property used as the primary residence of an individual
- 11 theretofore subject to the lien is released from the lien.
- 12 Section 3. This act shall take effect immediately JULY 1,
- 13 1991.
