AN ACT

- Amending the act of June 28, 1935 (P.L.477, No.193), entitled, 2 as amended, "An act providing for the payment of the salary, 3 medical and hospital expenses of members of the State Police 4 Force, of the enforcement officers and investigators employed by the Pennsylvania Liquor Control Board, and the parole 6 agents, enforcement officers and investigators of the 7 Pennsylvania Board of Probation and Parole, Capitol Police 8 officers, correction officers employed by the Department of Corrections whose principal duty is the care, custody and 9 control of inmates, psychiatric security aides employed by 10 the Department of Public Welfare and the Department of 11 12 Corrections whose principal duty is the care, custody, and control of the criminally insane, and drug enforcement agents of the Office of Attorney General whose principal duty is the 13 14 15 enforcement of the drug laws of the Commonwealth, members of 16 the Delaware River Port Authority Police and of policemen, 17 firemen and park guards by the Commonwealth of Pennsylvania, 18 the Delaware River Port Authority, counties, cities, boroughs, towns and townships, who are injured or contract 19 20 certain diseases in the performance of their duty; and providing that absence during such injury shall not reduce any usual sick leave period, "further providing for 21 22 23 compensation for service-related injuries.
- 24 The General Assembly of the Commonwealth of Pennsylvania
- 25 hereby enacts as follows:
- Section 1. Section 1(a) of the act of June 28, 1935
- 27 (P.L.477, No.193), referred to as the Enforcement Officer
- 28 Disability Benefits Law, amended December 19, 1986 (P.L.1733,

- 1 No.208), is amended to read:
- 2 Section 1. (a) Be it enacted, &c., That any member of the
- 3 State Police Force, any enforcement officer or investigator
- 4 employed by the Pennsylvania Liquor Control Board, and the
- 5 parole agents, enforcement officers and investigators of the
- 6 Pennsylvania Board of Probation and Parole, Capitol Police
- 7 officers, correction officers employed by the Department of
- 8 Corrections, whose principal duty is the care, custody and
- 9 control of inmates, psychiatric security aides employed by the
- 10 Department of Public Welfare and the Department of Corrections,
- 11 whose principal duty is the care, custody, and control of the
- 12 criminally insane, and drug enforcement agents of the Office of
- 13 Attorney General whose principal duty is the enforcement of the
- 14 drug laws of the Commonwealth, any member of the Delaware River
- 15 Port Authority Police or any policeman, fireman or park guard of
- 16 any county, city, borough, town or township, who is injured in
- 17 the performance of his duties including, in the case of firemen,
- 18 duty as special fire police, and by reason thereof is
- 19 temporarily incapacitated from performing his duties, shall be
- 20 paid by the Commonwealth of Pennsylvania if a member of the
- 21 State Police Force or an enforcement officer or investigator
- 22 employed by the Pennsylvania Liquor Control Board or the parole
- 23 agents, enforcement officers and investigators of the
- 24 Pennsylvania Board of Probation and Parole, Capitol Police
- 25 officers, correction officers employed by the Department of
- 26 Corrections, whose principal duty is the care, custody and
- 27 control of inmates, psychiatric security aides employed by the
- 28 Department of Public Welfare and the Department of Corrections,
- 29 whose principal duty is the care, custody, and control of the
- 30 criminally insane, and drug enforcement agents of the Office of

- 1 Attorney General whose principal duty is the enforcement of the
- 2 drug laws of the Commonwealth, or by the Delaware River Port
- 3 Authority if a member of the Delaware River Port Authority
- 4 Police or by the county, township or municipality, by which he
- 5 is employed, his full rate of salary, as fixed by ordinance or
- 6 resolution, until the disability arising therefrom has ceased.
- 7 All medical and hospital bills, incurred in connection with any
- 8 such injury, including psychiatric care for the individual and
- 9 <u>immediate family members</u>, shall be paid by the Commonwealth of
- 10 Pennsylvania or by the Delaware River Port Authority or by such
- 11 county, township or municipality. During the time salary for
- 12 temporary incapacity shall be paid by the Commonwealth of
- 13 Pennsylvania or by the Delaware River Port Authority or by the
- 14 county, city, borough, town or township, any workmen's
- 15 compensation, received or collected by any such employe for such
- 16 period, shall be turned over to the Commonwealth of Pennsylvania
- 17 or to the Delaware River Port Authority or to such county, city,
- 18 borough, town or township, and paid into the treasury thereof,
- 19 and if such payment shall not be so made by the employe the
- 20 amount so due the Commonwealth of Pennsylvania, the Delaware
- 21 River Port Authority or the county, city, borough, town or
- 22 township shall be deducted from any salary then or thereafter
- 23 becoming due and owing.

- 25 Section 2. This act shall take effect in 60 days.
