- 14 SECTION 2. SECTION 3 OF THE ACT IS REENACTED AND AMENDED TO
- 15 READ:
- 16 Section 3. State Board for Certification of Sewage Treatment
- 17 Plant and Waterworks Operators. --(A)(1) There is hereby created <—
- 18 within the Department of [Health] <u>ENVIRONMENTAL RESOURCES</u>, a <--

- 19 State Board for Certification of Sewage Treatment Plant and
- 20 Waterworks Operators. The board shall consist of the Secretary
- 21 of [Health] <u>ENVIRONMENTAL RESOURCES</u> of the Commonwealth of
- 22 Pennsylvania, or his representative, and five additional members
- 23 to be appointed by the Governor.
- 24 (2) One member shall be an employe of a municipality or
- 25 municipality authority which operates a sewage treatment plant,
- 26 water treatment plant or water distribution system or a
- 27 representative of a State association of municipalities or
- 28 municipality authorities.
- 29 (3) One member shall be an individual qualified under this
- 30 act to operate any water treatment plant.

- 1 $\underline{(4)}$ One member shall be the owner or official of a privately <---
- 2 owned waterworks.
- 3 (5) One member shall be an individual qualified under this <---
- 4 act to operate any sewage treatment plant.
- 5 (6) One member shall be on the teaching staff of the civil <---
- 6 or sanitary engineering department of an accredited Pennsylvania
- 7 university or college.
- 8 (B) The original appointed members of the board, in the
- 9 order listed above, shall hold office for one, two, three, three
- 10 and four years respectively. Thereafter, each appointment shall
- 11 be for a period of four years duration. The Governor may
- 12 reappoint board members for successive terms. Members of the
- 13 board shall remain in office until a successor is appointed and
- 14 qualified. If vacancies occur prior to completion of a term the
- 15 Governor shall appoint another member in accordance with this
- 16 section to fill the unexpired term.
- 17 <u>(C)</u> The Secretary of [Health] <u>ENVIRONMENTAL RESOURCES</u>, or
- 18 his representative, shall call the first meeting of the board at

- 19 which time a chairman and secretary of the board shall be
- 20 elected. Thereafter the chairman and secretary shall be elected
- 21 annually. Four members of the board shall constitute a quorum.
- 22 Meetings may be called by the chairman as needed to conduct the
- 23 business of the board.
- 24 (D) The members of the board shall receive no compensation
- 25 for their service but shall be reimbursed for actual and
- 26 necessary expenses incurred in the performance of their duties.
- 27 SECTION 3. SECTION 10 OF THE ACT IS AMENDED TO READ:
- 28 SECTION 10. SUSPENSION AND REVOCATION. -- THE BOARD MAY
- 29 SUSPEND OR REVOKE THE CERTIFICATE OF ANY OPERATOR IF IT HAS
- 30 FOUND SAID OPERATOR TO BE INCOMPETENT TO OPERATE A SEWAGE

- 1 TREATMENT PLANT, WATER TREATMENT PLANT OR DISTRIBUTION SYSTEM OF
- 2 THE CLASSIFICATION FOR WHICH HE IS CERTIFIED OR TO HAVE
- 3 WILLFULLY NEGLECTED HIS DUTY IN THE OPERATION OF ANY SUCH PLANT
- 4 OR SYSTEM, OR TO HAVE DISREGARDED OR DISOBEYED THE LAWFUL
- 5 ORDERS, RULES OR REGULATIONS OF THE BOARD RELATIVE TO
- 6 CERTIFICATION OR THE LAWFUL ORDERS OF THE PENNSYLVANIA
- 7 DEPARTMENT OF [HEALTH OR THE SANITARY WATER BOARD] ENVIRONMENTAL
- 8 RESOURCES RELATIVE TO SEWAGE TREATMENT PLANTS, WATER TREATMENT
- 9 PLANTS OR DISTRIBUTION SYSTEMS.
- 10 SECTION 4. SECTION 12 OF THE ACT, AMENDED JUNE 23, 1970
- 11 (P.L.435, NO.146), IS AMENDED TO READ:
- 12 SECTION 12. FEES.--EACH APPLICATION FOR CERTIFICATION AS
- 13 OPERATOR SHALL BE ACCOMPANIED BY [A FEE OF TEN DOLLARS (\$10).
- 14 CERTIFICATES SHALL EXPIRE ON THE LAST DAY OF JUNE OF THE FIRST
- 15 EVEN-NUMBERED YEAR FOLLOWING THE YEAR OF THEIR ISSUANCE AND MUST
- 16 BE RENEWED BIENNIALLY IN THE MANNER PRESCRIBED BY THE
- 17 DEPARTMENT. THE RENEWAL FEE SHALL BE THREE DOLLARS (\$3).] THE
- 18 FEE PRESCRIBED BY LAW AND MUST BE RENEWED ANNUALLY IN THE MANNER
- 19 PRESCRIBED BY THE SECRETARY OF ENVIRONMENTAL RESOURCES UPON
- 20 PAYMENT OF THE REQUIRED RENEWAL FEE.
- 21 SECTION 5. SECTION 15 OF THE ACT IS AMENDED TO READ:
- 22 SECTION 15. CIVIL RELIEF. -- THE SECRETARY OF [HEALTH]
- 23 ENVIRONMENTAL RESOURCES MAY MAINTAIN AN ACTION IN THE NAME OF
- 24 THE COMMONWEALTH FOR AN INJUNCTION OR OTHER PROCESS AGAINST ANY
- 25 PERSON TO RESTRAIN OR PREVENT SUCH PERSON FROM VIOLATING THE
- 26 PROVISIONS OF THIS ACT OR ANY ORDER, RULES OR REGULATION OF THE
- 27 BOARD ISSUED PURSUANT TO THE PROVISIONS OF THIS ACT.
- 28 Section 2 6. This act, with respect to the State Board for
- 29 Certification of Sewage Treatment Plant and Waterworks Operators
- 30 reestablishes this board, which was terminated pursuant to the

- 3 Section 3 7. The presently confirmed members of the State

- 4 Board for Certification of Sewage Treatment Plant and Waterworks
- 5 Operators as of December 31, 1988, shall continue to serve as
- 6 members of the board until their successors are appointed and
- 7 qualified.
- 8 Section 4 8. All powers and duties of the State Board for
- 9 Certification of Sewage Treatment Plant and Waterworks Operators
- 10 shall remain as heretofore provided by law.
- Section $\frac{5}{9}$. All actions of the State Board for
- 12 Certification of Sewage Treatment Plant and Waterworks Operators
- 13 prior to the effective date of this act are hereby ratified and
- 14 confirmed.
- 15 Section 6 10. The State Board for Certification of Sewage <
- 16 Treatment Plant and Waterworks Operators shall be subject to
- 17 evaluation and review and shall terminate on December 31, 1997,
- 18 in the manner provided for by the act of December 22, 1981
- 19 (P.L.508, No.142), known as the Sunset Act.
