## AN ACT

- 1 Providing for restrooms in facilities where the public
- 2 congregates; and requiring that restroom facilities be
- 3 provided for women on an equitable basis.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Statement of purpose.
- 7 The purpose of this act is to end the inequitable delays
- 8 which women face when they need to use restroom facilities in
- 9 public places when men are rarely required to wait for the same
- 10 purpose.
- 11 Section 2. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Department." The Department of Labor and Industry of the
- 16 Commonwealth of Pennsylvania.
- 17 "Facilities where the public congregates." Sports and

- 1 entertainment arenas, stadiums, community and convention halls,
- 2 specialty event centers, amusement facilities, ski resorts, and
- 3 public middle schools and high schools. The term includes
- 4 specialty event centers in public parks.
- 5 "Public building." A building owned or leased by the
- 6 Commonwealth, an agency or instrumentality of the Commonwealth
- 7 or a political subdivision.
- 8 "Specialty event center." An open arena used for rallies,
- 9 concerts, exhibits, etc., with no permanent structure for
- 10 purposes of assembly.
- 11 Section 3. Restroom requirements.
- 12 Publicly and privately owned facilities where the public
- 13 congregates shall be equipped with sufficient temporary or
- 14 permanent restrooms to meet the needs of the public at peak
- 15 hours. More water closets and lavatories shall be provided for
- 16 women than for men by a ratio determined by the department.
- 17 Section 4. Standards.
- 18 The department shall adopt, by regulation, standards with
- 19 respect to all public and private facilities where the public
- 20 congregates, unless such facilities are exempt from coverage
- 21 under section 6.
- 22 Section 5. Applicability.
- 23 This act shall apply to facilities where the public
- 24 congregates which commence construction, or which undertake
- 25 structural alterations, repairs or improvements exceeding 50% of
- 26 the entire facility, on or after January 1, 1990.
- 27 Section 6. Exemptions.
- This act shall not apply to the following:
- 29 (1) Any hotel. For purposes of this section, "hotel"
- 30 means an establishment in which there exists the relationship

- of guests and innkeeper between the occupants and the owner
- or operator of the establishment. The existence of some other
- 3 legal relationship between the occupants and owner or
- 4 operator shall be immaterial.
- 5 (2) Any public eating or drinking place as defined in
- 6 the act of May 23, 1945 (P.L.926, No.369), referred to as the
- 7 Public Eating and Drinking Place Law.
- 8 (3) Community and municipal parks with seating capacity
- 9 for less than 500 persons.
- 10 Section 7. Effective date.
- 11 This act shall take effect immediately.
