AN ACT

- Amending the act of April 6, 1980 (P.L.82, No.28), entitled "An 2 act providing for the continuation, operation and 3 administration of the school for indigent orphans known as 4 the Thaddeus Stevens State School of Technology in Lancaster, Pennsylvania in which school instruction shall be given in 6 all basic educational subjects and additional training given 7 in elementary manual skills, elements of farming and other programs of similar nature, " further providing for the powers 8 9 and duties of the board of trustees and the president, for admissions, for the course of instruction and for rights of 10 11 faculty and staff; and making an editorial change. 12 AMENDING THE ACT OF MARCH 10, 1949 (P.L.30, NO.14), ENTITLED "AN 13 ACT RELATING TO THE PUBLIC SCHOOL SYSTEM, INCLUDING CERTAIN PROVISIONS APPLICABLE AS WELL TO PRIVATE AND PAROCHIAL 14 15 SCHOOLS; AMENDING, REVISING, CONSOLIDATING AND CHANGING THE 16 LAWS RELATING THERETO, " FURTHER PROVIDING FOR THE 17 CONTINUATION, OPERATION AND ADMINISTRATION OF THE SCHOOL FOR 18 INDIGENT ORPHANS KNOWN AS THE THADDEUS STEVENS STATE SCHOOL 19 OF TECHNOLOGY IN LANCASTER, PENNSYLVANIA IN WHICH SHALL BE 20 OFFERED TWO-YEAR POSTSECONDARY VOCATIONAL-TECHNICAL EDUCATION PROGRAMS; FURTHER PROVIDING FOR THE FACTOR FOR EDUCATIONAL 21 22 EXPENSES AND AID TO SMALL DISTRICTS; PROVIDING FOR CERTAIN 23 EQUIPMENT GRANTS; AND MAKING A REPEAL. 24 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 26 Section 1. The title and sections 6, 7 and 8 of the act of
- 27 April 6, 1980 (P.L.82, No.28), known as the Thaddeus Stevens

- 1 State School of Technology Act, are amended to read:
- 2 AN ACT
- 3 Providing for the continuation, operation and administration of
- 4 the school for indigent orphans known as the Thaddeus Stevens
- 5 State School of Technology in Lancaster, Pennsylvania in
- 6 which [school instruction shall be given in all basic
- 7 educational subjects and additional training given in
- 8 elementary manual skills, elements of farming and other
- 9 programs of similar nature] two year postsecondary programs
- 10 <u>in vocational technical education shall be given.</u>
- 11 Section 6. Board of trustees.
- 12 The board of trustees shall consist of nine members, who
- 13 shall serve without compensation, and be appointed by the
- 14 Governor, by and with the advice and consent of the Senate. Said
- 15 trustees shall be a body politic or corporate, of the name of
- 16 the Thaddeus Stevens State School of Technology. They shall
- 17 [manage and direct the affairs of the institution], under
- 18 section 1311 of the act of April 9, 1929 (P.L.177, No.175),
- 19 known as "The Administrative Code of 1929," have general
- 20 <u>direction and control of the property and management of the</u>
- 21 <u>institution; develop broad institutional policy;</u> and make all
- 22 necessary bylaws and regulations, not inconsistent with either
- 23 the provisions of the Constitution, laws of the Commonwealth, or
- 24 rules and regulations of the State Board of Education. Of the
- 25 trustees first appointed, three shall serve for one year, three
- 26 for two years, and three for three years, and at the expiration
- 27 of the respective periods the vacancies shall be filled by the
- 28 Governor, by appointment, for three years, as hereinbefore
- 29 provided; and should any vacancy occur by death or resignation,
- 30 or otherwise, of any trustee, such vacancy shall be filled, by

- 1 appointment as aforesaid, for the unexpired term of said
- 2 trustee. The Secretary of Education shall be ex officio member
- 3 of the board of trustees.
- 4 Section 7. President of the school.
- 5 The chief administrator and academic officer of the Thaddeus
- 6 Stevens State School of Technology shall be the president whose
- 7 duties shall be defined by the board of trustees and approved by
- 8 the Secretary of Education. [Other administrative personnel
- 9 shall be designated at the discretion of the board of trustees.]
- 10 Section 8. [Individuals eligible for admission] Admission of
- 11 <u>students and educational program.</u>
- 12 (a) [There shall be received into the institution indigent
- 13 orphan persons or other deserving persons, from the State of
- 14 Pennsylvania, above the age of 15 years, whose admission may be
- 15 applied for under such regulations as the board of trustees may
- 16 adopt.] The school shall provide a program of education
- 17 hereinafter defined for those persons admitted to the
- 18 <u>institution pursuant to section 4.</u> In considering such admission
- 19 no preference shall be shown on account of race, color, sex,
- 20 marital status, ethnic group or religion.
- 21 (b) The course of instruction shall be the equivalent level
- 22 of [the junior and senior year of a four year public vocational-
- 23 technical high school and/or a two year] a two year
- 24 postsecondary institution which shall include[:
- 25 (1) vocational vocational technical education of no
- 26 more than two years leading to the awarding of [diplomas,]
- 27 certificates or associate degrees, when approved by the
- 28 Secretary of Education in accordance with rules and
- 29 regulations established by the State Board for this level of
- 30 education, for the purpose of fitting pupils to pursue

- 1 effectively a recognized profitable employment[; and
- 2 (2) evening or other classes providing such instruction
- 3 for persons who have left full time school providing the
- 4 board of trustees shall establish and charge tuition for such
- 5 instruction that will cover the total cost of instruction
- 6 including all direct costs and the allocable portion of all
- 7 applicable indirect costs].
- 8 Section 2. Section 10 of the act is repealed.
- 9 Section 3. The act is amended by adding a section to read:
- 10 Section 10.1. Rights of faculty and staff.
- 11 Except as otherwise provided by law, faculty employed in the
- 12 Thaddeus Stevens State School of Technology shall enjoy the same
- 13 privileges, including tenure rights, and be subject to the same
- 14 laws, except certification, as faculty in the public schools of
- 15 this Commonwealth and to collective bargaining agreements
- 16 entered into under the act of July 23, 1970 (P.L.563, No.195),
- 17 known as the "Public Employe Relations Act."
- 18 Section 4. This act shall take effect immediately.
- 19 SECTION 1. THE ACT OF MARCH 10, 1949 (P.L.30, NO.14), KNOWN
- 20 AS THE PUBLIC SCHOOL CODE OF 1949, IS AMENDED BY ADDING AN
- 21 ARTICLE TO READ:
- 22 ARTICLE XIX-B.
- 23 THADDEUS STEVENS STATE SCHOOL OF TECHNOLOGY.
- 24 SECTION 1901-B. SHORT TITLE. -- THIS ARTICLE SHALL BE KNOWN
- 25 AND MAY BE CITED AS THE "THADDEUS STEVENS STATE SCHOOL OF
- 26 TECHNOLOGY ACT."
- 27 SECTION 1902-B. LEGISLATIVE INTENT.--IT IS THE INTENT OF THE
- 28 GENERAL ASSEMBLY TO PROVIDE FOR THE CONTINUED EXISTENCE,
- 29 OPERATION AND ADMINISTRATION OF THE THADDEUS STEVENS STATE
- 30 <u>SCHOOL OF TECHNOLOGY</u>.

- 1 SECTION 1903-B. AUTHORIZATION TO CONTINUE SCHOOL
- 2 OPERATIONS. -- THE INSTITUTION KNOWN AS THE THADDEUS STEVENS STATE
- 3 SCHOOL OF TECHNOLOGY, ESTABLISHED AND OPERATED PURSUANT TO THE
- 4 REPEALED PROVISIONS OF THE ACT OF MAY 11, 1905 (P.L.518,
- 5 NO.429), IS HEREBY AUTHORIZED TO CONTINUE OPERATIONS AND TO
- 6 RECEIVE ANY STATE FUNDS OR AID TO WHICH IT MAY BE ENTITLED. ALL
- 7 LAWFUL ACTIONS AND EXPENDITURES MADE BY SAID INSTITUTION BETWEEN
- 8 OCTOBER 4, 1978, AND THE EFFECTIVE DATE OF THIS ACT ARE HEREBY
- 9 RATIFIED AND APPROVED BY THE GENERAL ASSEMBLY.
- 10 SECTION 1904-B. SCHOOL PURPOSES.--(A) THE THADDEUS STEVENS
- 11 STATE SCHOOL OF TECHNOLOGY, LOCATED IN LANCASTER, PENNSYLVANIA,
- 12 SHALL CONTINUE TO PROVIDE FOR THE POST SECONDARY EDUCATION AND
- 13 TRAINING OF INDIGENT ORPHANS.
- 14 (B) IF A SUFFICIENT NUMBER OF INDIGENT ORPHANS QUALIFIED FOR
- 15 ADMISSION PURSUANT TO SCHOOL STANDARDS FAIL TO APPLY, THEN THE
- 16 BOARD OF TRUSTEES OF THIS COOPERATION MAY ADMIT, FIRST OTHER
- 17 <u>DESERVING PERSONS</u>, AND, THEREAFTER ORPHANS WHO MAY NOT BE
- 18 INDIGENT, AS THE TRUSTEES IN THEIR BEST JUDGMENT MAY THINK
- 19 PROPER.
- 20 (C) THOSE SHALL BE DEEMED ORPHANS WHO HAVE LOST EITHER
- 21 PARENT.
- 22 SECTION 1905-B. SCHOOL BUILDINGS.--THE BUILDINGS SHALL BE
- 23 SEPARATED, AND SHALL EMBRACE ONE OR MORE SCHOOLHOUSES, AND ONE
- 24 OR MORE WORKSHOPS, AND AN ISOLATING HOSPITAL, ALL ON SUCH SCALE
- 25 AS WILL CREATE AN INSTITUTION ACCOMMODATING NOT LESS THEN TWO
- 26 HUNDRED PERSONS, PLANNED AND LOCATED FOR EASY AND NATURAL
- 27 ADDITIONS, AS THE NEEDS OF THE INSTITUTION MAY DEMAND.
- 28 <u>SECTION 1906-B. BOARD OF TRUSTEES.--THE BOARD OF TRUSTEES</u>
- 29 SHALL CONSIST OF NINE MEMBERS, WHO SHALL SERVE WITHOUT
- 30 COMPENSATION, AND BE APPOINTED BY THE GOVERNOR, BY AND WITH THE

- 1 ADVICE AND CONSENT OF THE SENATE. SAID TRUSTEES SHALL BE A BODY
- 2 POLITIC OR CORPORATE, OF THE NAME OF THE THADDEUS STEVENS STATE
- 3 SCHOOL OF TECHNOLOGY. THEY SHALL, UNDER SECTION 1311 OF THE ACT
- 4 OF APRIL 9, 1929 (P.L.177, NO.175), KNOWN AS "THE ADMINISTRATIVE
- 5 CODE OF 1929," HAVE GENERAL DIRECTION AND CONTROL OF THE
- 6 PROPERTY AND MANAGEMENT OF THE INSTITUTION; DEVELOP BROAD
- 7 INSTITUTIONAL POLICY; AND MAKE ALL NECESSARY BYLAWS AND
- 8 REGULATIONS, NOT INCONSISTENT WITH EITHER THE PROVISIONS OF THE
- 9 CONSTITUTION, LAWS OF THE COMMONWEALTH, OR RULES AND REGULATIONS
- 10 OF THE STATE BOARD OF EDUCATION. OF THE TRUSTEES FIRST
- 11 APPOINTED, THREE SHALL SERVE FOR ONE YEAR, THREE FOR TWO YEARS,
- 12 AND THREE FOR THREE YEARS, AND AT THE EXPIRATION OF THE
- 13 RESPECTIVE PERIODS THE VACANCIES SHALL BE FILLED BY THE
- 14 GOVERNOR, BY APPOINTMENT, FOR THREE YEARS, AS HEREINBEFORE
- 15 PROVIDED; AND SHOULD ANY VACANCY OCCUR BY DEATH OR RESIGNATION,
- 16 OR OTHERWISE, OF ANY TRUSTEE, SUCH VACANCY SHALL BE FILLED, BY
- 17 APPOINTMENT AS AFORESAID, FOR THE UNEXPIRED TERM OF SAID
- 18 TRUSTEE. THE SECRETARY OF EDUCATION SHALL BE EX OFFICIO MEMBER
- 19 OF THE BOARD OF TRUSTEES.
- 20 SECTION 1907-B. PRESIDENT OF SCHOOL.--THE CHIEF
- 21 ADMINISTRATOR AND ACADEMIC OFFICER OF THE THADDEUS STEVENS STATE
- 22 SCHOOL OF TECHNOLOGY SHALL BE THE PRESIDENT WHOSE DUTIES SHALL
- 23 BE DEFINED BY THE BOARD OF TRUSTEES AND APPROVED BY THE
- 24 <u>SECRETARY OF EDUCATION.</u>
- 25 SECTION 1908-B. INDIVIDUALS ELIGIBLE FOR ADMISSION.--(A)
- 26 THE SCHOOL BOARD SHALL PROVIDE A PROGRAM OF EDUCATION
- 27 HEREINAFTER DEFINED FOR THOSE PERSONS ADMITTED TO THE
- 28 INSTITUTION PURSUANT TO SECTION 1904-B. IN CONSIDERING SUCH
- 29 ADMISSION NO PREFERENCE SHALL BE SHOWN ON ACCOUNT OF RACE,
- 30 COLOR, SEX, MARITAL STATUS, ETHNIC GROUP OR RELIGION.

- 1 (B) THE COURSE OF INSTRUCTION SHALL BE THE EQUIVALENT LEVEL
- 2 <u>A TWO-YEAR POSTSECONDARY INSTITUTION WHICH SHALL INCLUDE</u>
- 3 <u>VOCATIONAL-TECHNICAL EDUCATION OF NO MORE THAN TWO YEARS LEADING</u>
- 4 TO THE AWARDING OF CERTIFICATES OR ASSOCIATE DEGREES, WHEN
- 5 APPROVED BY THE SECRETARY OF EDUCATION IN ACCORDANCE WITH RULES
- 6 AND REGULATIONS ESTABLISHED BY THE STATE BOARD FOR THIS LEVEL OF
- 7 EDUCATION, FOR THE PURPOSE OF FITTING PUPILS TO PURSUE
- 8 EFFECTIVELY A RECOGNIZED PROFITABLE EMPLOYMENT.
- 9 SECTION 1909-B. TUITION STUDENTS.--IN ADDITION TO STATE-
- 10 SUPPORTED RESIDENT STUDENTS AS DEFINED IN SECTION 1904-B, THE
- 11 BOARD OF TRUSTEES MAY ADMIT FOR STUDY AT THE SCHOOL PART-TIME OR
- 12 FULL-TIME TUITION STUDENTS, AND SHALL FIX AND CHARGE TUITION
- 13 RATES AS APPROVED BY THE SECRETARY OF EDUCATION FOR SUCH
- 14 STUDENTS. ALL MONEY COLLECTED AS TUITION BY THE INSTITUTION
- 15 SHALL BE PAID INTO THE GENERAL FUND AND CREDITED TO THE
- 16 APPROPRIATIONS MADE TO THE INSTITUTION.
- 17 SECTION 1910-B. RIGHTS OF FACULTY AND STAFF.--EXCEPT AS
- 18 OTHERWISE PROVIDED BY LAW, FACULTY EMPLOYED IN THE THADDEUS
- 19 STEVENS STATE SCHOOL OF TECHNOLOGY SHALL CONTINUE TO ENJOY THE
- 20 SAME RIGHTS AND PRIVILEGES AS PROVIDED ON JUNE 30, 1990. NOTHING
- 21 CONTAINED HEREIN SHALL SUPERSEDE OR PREEMPT ANY PROVISIONS OF A
- 22 COLLECTIVE BARGAINING AGREEMENT NEGOTIATED BETWEEN THE
- 23 COMMONWEALTH AND AN EXCLUSIVE REPRESENTATIVE OF THE EMPLOYES IN
- 24 ACCORDANCE WITH THE ACT OF JULY 23, 1970 (P.L.563, NO.195),
- 25 KNOWN AS THE "PUBLIC EMPLOYE RELATIONS ACT." IN NO EVENT SHALL
- 26 THE FACULTY BE CONSIDERED TO BE IN THE CLASSIFIED SERVICE, AS
- 27 DEFINED BY THE ACT OF AUGUST 5, 1941 (P.L.752, NO.286), KNOWN AS
- 28 THE "CIVIL SERVICE ACT."
- 29 <u>SECTION 1911-B. VISITATION PRIVILEGES.--THE GOVERNOR,</u>
- 30 <u>SECRETARY OF EDUCATION, JUDGES OF THE SEVERAL COURTS OF THE</u>

- 1 COMMONWEALTH, AND SENATORS AND REPRESENTATIVES OF THE GENERAL
- 2 ASSEMBLY SHALL BE EX OFFICIO VISITORS OF SAID INSTITUTION; AND
- 3 IT SHALL BE SUBJECT TO INSPECTION BY THE DEPARTMENT OF
- 4 EDUCATION; AND AN ANNUAL REPORT OF THE CONDUCT AND MANAGEMENT OF

- 2 EACH SCHOOL DISTRICT WHICH HAS AN AVERAGE DAILY MEMBERSHIP OF
- 3 ONE THOUSAND FIVE HUNDRED (1,500) OR LESS AND HAS A MARKET
- 4 VALUE/INCOME AID RATIO OF FIVE THOUSAND TEN-THOUSANDTHS (0.5000)
- 5 OR GREATER, AN AMOUNT EQUAL TO FIFTY DOLLARS (\$50) MULTIPLIED BY

- 6 INFORMATION IT RECEIVES FROM COLLEGES AND UNIVERSITIES THE
- 7 DEPARTMENT SHALL CERTIFY THE NUMBER OF FULL-TIME EQUIVALENT
- 8 STUDENTS ATTENDING EACH ELIGIBLE INSTITUTION DURING THE MOST
- 9 <u>RECENT YEAR FOR WHICH DATA IS AVAILABLE.</u>
- 10 SECTION 2703-E. INSTITUTIONAL EQUIPMENT GRANTS.--FOR THE
