AN ACT

- 1 Amending the act of May 1, 1933 (P.L.103, No.69), entitled "An
- 2 act concerning townships of the second class; and amending,
- 3 revising, consolidating, and changing the law relating
- 4 thereto, "further providing for the compensation of township
- 5 auditors.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 545 of the act of May 1, 1933 (P.L.103,
- 9 No.69), known as The Second Class Township Code, reenacted and
- 10 amended July 10, 1947 (P.L.1481, No.567) and amended October 16,
- 11 1981 (P.L.291, No.100) and April 8, 1982 (P.L.256, No.77), is
- 12 amended to read:
- 13 Section 545. Meetings; Duties; Quorum; Surcharges;
- 14 Compensation. -- The auditors of townships shall meet annually, at
- 15 the place of meeting of the supervisors, on the day following
- 16 the day which is fixed by this act for organization of the
- 17 township supervisors; and shall organize by the election of a
- 18 chairman and secretary, and shall audit, settle, and adjust the

- 1 accounts of the supervisors, superintendents, roadmasters,
- 2 treasurer, and tax collector of the township, and fix the
- 3 compensations for the current year authorized in section 515
- 4 hereof. Two auditors shall constitute a quorum. The auditors
- 5 shall also make an audit of the dockets, transcripts, and other
- 6 official records of the justices of the peace to determine the
- 7 amounts of fines and costs paid over or due the township, and
- 8 the dockets and records of the justices of the peace shall be
- 9 open to inspection by the auditors for such purpose. Unless
- 10 otherwise agreed to by the auditors and the officer being
- 11 audited, the audit shall he conducted at the place the records
- 12 of the officer are normally kept.
- 13 Upon the death or resignation of any of the above officers
- 14 the auditor, upon call of the chairman, shall meet and audit the
- 15 accounts of the former incumbent, and at that time fix the
- 16 compensation of his successor if authorized by this act to fix
- 17 the compensation for such office.
- 18 Any elected or appointed officer, whose act, error or
- 19 omission has contributed to the financial loss of any township,
- 20 shall be surcharged by the auditors with the amount of such
- 21 loss, and the surcharge of any such officer shall take into
- 22 consideration as its basis, the results of such act, error or
- 23 omission and the results had the procedure been strictly
- 24 according to law. The provisions hereof limiting the amount of
- 25 any surcharge shall not apply to cases involving fraud or
- 26 collusion on the part of such officers, nor to any penalty
- 27 ensuing to the benefit of or payable to the Commonwealth.
- 28 Each auditor shall receive [thirty dollars] a maximum of
- 29 fifty dollars (\$50) per diem, as fixed by ordinance, for each
- 30 day necessarily employed in the duties of his office, to be paid

- 1 out of the funds of the township. In no event shall any auditor
- 2 in a township having a population of ten thousand (10,000) or
- 3 less be entitled to receive more than [six hundred dollars
- 4 (\$600)] one thousand dollars (\$1,000) for any calendar year. In
- 5 no event shall any auditor in a township having a population in
- 6 excess of ten thousand (10,000) be entitled to receive more than
- 7 [twelve hundred dollars (\$1,200)] two thousand dollars (\$2,000)
- 8 for any calendar year. A day shall consist of not less than five
- 9 hours in the aggregate.
- 10 Section 2. Section 547(a) of the act, amended December 17,
- 11 1986 (P.L.1687, No.199), is amended to read:
- 12 Section 547. Completion, Filing and Publication of Annual
- 13 Township Report and Financial Statement.--(a) The auditors
- 14 shall complete their audit, settlement, and adjustment prior to
- 15 March first of each year, and in townships having a population
- 16 of ten thousand (10,000) or less, no more than twenty days shall
- 17 be expended on such audit. In townships having a population in
- 18 excess of ten thousand (10,000), no more than forty days shall
- 19 be expended on such audit. In addition to the time actually
- 20 expended by the auditors to complete their audit, settlement and
- 21 adjustment within such twenty or forty days limitations, the
- 22 auditors may expend not more than a total of ten additional days
- 23 at a compensation [of thirty dollars (\$30)] not to exceed fifty
- 24 <u>dollars (\$50)</u> per day to audit the accounts of any public
- 25 official who handles public funds when a vacancy occurs in the
- 26 office of such public official.

- 28 Section 3. This act shall take effect in 60 days.
