AN ACT

- 1 Providing for the preservation of historic burial places and
- 2 tombs, monuments and gravestones; and imposing penalties.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Historic
- 7 Burial Places Preservation Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Burial ground authority." A municipality, ecclesiastical
- 13 society, cemetery association or other entity that has charge of
- 14 a historic burial place.
- 15 "Historic burial place." A tract of land that has been in
- 16 existence as a burial ground for more than 100 years wherein
- 17 there have been no burials for at least 50 years and wherein

- 1 there will be no future burials.
- 2 Section 3. Restriction on alienation and use of historic burial
- 3 places.
- 4 No municipality shall alienate or condemn through eminent
- 5 domain proceedings a historic burial place or appropriate a
- 6 historic burial place to any use other than that of a burial
- 7 ground. No portion of any such burial place shall be taken for
- 8 public use without the approval of the General Assembly. If any
- 9 historic burial place is appropriated for any other use and the
- 10 bodies buried in the historic burial place or the monuments,
- 11 gravestones or other memorials are removed, the burial ground
- 12 authority shall preserve a record of the removal indicating the
- 13 date of the removal and the site or place to which the removal
- 14 was made.
- 15 Section 4. Restrictions on removal of tombs, monuments, etc.
- 16 (a) General rule.--No fence, tomb, monument or gravestone or
- 17 fragment thereof within a historic burial place shall be
- 18 destroyed. No fence, tomb, monument or gravestone or fragment
- 19 thereof within any historic burial place shall be removed except
- 20 in accordance with the provisions of this section.
- 21 (b) Procedure or lawful removal.--A gravestone or other
- 22 memorial for the dead may be removed for the purpose of repair
- 23 or replacement, reproduction or preservation and display in an
- 24 accredited museum with:
- 25 (1) the consent of the owner of the historic burial lot
- in which the gravestone or memorial is placed or the consent
- of a lineal descendant of the deceased or, if such owner or
- lineal descendant is unknown, the consent of the burial
- 29 ground authority; and
- 30 (2) an order of the court of common pleas of the county

- 1 in which the historic burial place is located.
- 2 (c) Court order for removal. -- Upon written application of
- 3 the consenting owner, lineal descendant or burial ground
- 4 authority, the court of common pleas may, after a hearing, with
- 5 notice of the hearing having been given to interested parties
- 6 and otherwise as the court deems appropriate, order the removal
- 7 of the gravestone or memorial if it finds that the removal is
- 8 necessary or desirable for the protection and preservation of
- 9 the gravestone or memorial.
- 10 Section 5. Offenses.
- 11 (a) Destruction of tombs, monuments, gravestones, etc.--A
- 12 person who, without authorization of the owner of a historic
- 13 burial lot or a lineal descendant of the deceased or of the
- 14 historic burial ground authority, commits a misdemeanor of the
- 15 second degree if:
- 16 (1) he intentionally destroys, mutilates, defaces or
- 17 removes any tomb, monument, gravestone or other structure or
- any portion or fragment thereof, placed or designed as a
- 19 memorial for the dead, or any fence, railing, curb or other
- 20 enclosure for the burial of the dead in a historic burial
- 21 place; or
- 22 (2) he wantonly or maliciously disturbs the contents of
- any tomb or grave in a historic burial place.
- 24 (b) Unlawful possession of monuments, gravestones or certain
- 25 other structures. -- A person commits a misdemeanor of the second
- 26 degree if he possesses or sells, offers for sale or attempts to
- 27 sell or transfers or disposes of any monument, gravestone or
- 28 other structure or any portion or fragment thereof, placed or
- 29 designed for a memorial of the dead, knowing that it has been
- 30 unlawfully removed from a historic burial place.

- 1 Section 6. Effective date.
- 2 This act shall take effect in 60 days.
