AN ACT

- Amending the act of December 17, 1981 (P.L.435, No.135), 2 entitled "An act providing for the regulation of pari-mutuel 3 thoroughbred horse racing and harness horse racing activities; imposing certain taxes and providing for the 5 disposition of funds from pari-mutuel tickets, providing for 6 local option concerning the establishment of off-track pari-7 mutuel wagering facilities within municipalities. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. The act of December 17, 1981 (P.L.435, No.135), 11 known as the Race Horse Industry Reform Act, is amended by 12 adding a section to read: Section 238. Local option. 13
- 14 (a) In any municipality, an election may be held, not more
- 15 than once, to determine the will of the electors with respect to
- the establishment of facilities for the conduct of off-track 16
- pari-mutuel wagering within the limits of such municipality. 17
- 18 Whenever a number of electors equal to at least 25% of the
- 19 highest vote cast for any office in the municipality at the last

- 1 preceding general election shall file a petition with the board
- 2 of elections of the county, or the governing body of the
- 3 <u>municipality adopts, by a majority vote, a resolution to place</u>
- 4 <u>such a question before the electors and a copy of the resolution</u>
- 5 is filed with the board of elections of the county, the county
- 6 board of elections shall cause the question to be submitted to
- 7 the electors at the next election, unless the question is filed
- 8 within three calendar months preceding the month in which the
- 9 next election will be held, in which case the referendum shall
- 10 be conducted at the next succeeding election. The ballot
- 11 question shall be in the following form:
- 12 <u>Do you favor the establishment of a facility for the</u>
- conduct of off-track pari-mutuel wagering in the (name of
- 14 <u>municipality</u>)?
- (b) If a majority of the electors voting on the question
- 16 vote "no," then the commissions shall have no power to approve
- 17 the establishment of a facility for the conduct of an off-track
- 18 pari-mutuel facility within that municipality and no person or
- 19 <u>facility shall be permitted to conduct or to continue conducting</u>
- 20 off-track pari-mutuel wagering within the municipality even if
- 21 such facility received any prior commission approval to do so.
- 22 (c) Proceedings under this section shall be in accordance
- 23 with the act of June 3, 1937 (P.L.1333, No.320), known as the
- 24 <u>"Pennsylvania Election Code."</u>
- 25 (d) As used in this section, the term "election" means a
- 26 general or municipal election.
- 27 Section 2. This act shall take effect immediately.
