AN ACT

- Amending the act of November 4, 1983 (P.L.217, No.63), entitled "An act establishing a program of limited pharmaceutical assistance for the elderly; granting powers to and imposing duties on the Department of Aging; establishing a payment 3 4 system; making provisions for funding; providing for reports; and fixing penalties for violations of the pharmaceutical 6 7 assistance program, "further defining "maximum annual 8 income"; and further providing for copayments.

- 10 hereby enacts as follows:
- 11 Section 1. The definition of "maximum annual income" in
- 12 section 3 of the act of November 4, 1983 (P.L.217, No.63), known
- 13 as the Pharmaceutical Assistance Contract for the Elderly Act,
- amended December 17, 1984 (P.L.1002, No.202), is amended to 14

- 1 "Maximum annual income." Annual income as determined by the
- 2 department. Such amount shall not exceed [\$12,000] \$20,000 in
- 3 the case of single persons nor [\$15,000] \$25,000 in the case of
- 4 the combined annual income of married persons. For eligibility
- 5 and copayment determination, this amount shall be rounded to the
- 6 <u>nearest dollar.</u>

- 8 Section 2. Section 4(e)(5) of the act is repealed.
- 9 Section 3. The act is amended by adding a section to read:
- 10 <u>Section 4.2. Copayment schedule.</u>
- 11 (a) General rule. -- Copayments shall be made in accordance
- 12 with the following:

16	5,001 - 10,000	15% of prescription cost

- 19 (b) Definition.--As used in this section the term
- 20 <u>"prescription cost" shall be that amount charged to the</u>
- 21 <u>department for reimbursement for such prescription.</u>
- 22 Section 4. This act shall take effect January 1, 1992.
