AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, 2 3 special and primary elections, the nomination of candidates, primary and election expenses and election contests; creating 5 and defining membership of county boards of elections; 6 imposing duties upon the Secretary of the Commonwealth, 7 courts, county boards of elections, county commissioners; 8 imposing penalties for violation of the act, and codifying, revising and consolidating the laws relating thereto; and 9 10 repealing certain acts and parts of acts relating to 11 elections, providing for a procedure for certain electors 12 AND FOR APPORTIONMENT OF THE COMMONWEALTH INTO CONGRESSIONAL 13 DISTRICTS. 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1.
