AN ACT

Creating a uniform photo identification card system for all 2 municipal police officers and municipal authority security 3 officers employed in this Commonwealth; requiring all municipal police and municipal authority security officers to 4 5 carry uniform photo identification cards for public identification purposes; creating a central computerized 7 registry of all municipal police officers employed in this 8 Commonwealth; creating educational programs to promote public 9 awareness of the municipal police identification card system 10 and municipal police registry; imposing additional 11 responsibilities on the Municipal Police Officers' Education and Training Commission, the Department of Education and the 12 13 Department of Transportation; providing penalties; and making 14 an appropriation.

- 12 hereby enacts as follows:
- 13 Section 1. Short title.
- 14 This act shall be known and may be cited as the Uniform
- 15 Municipal Police Identification Act.
- 16 Section 2. Legislative findings and purpose.
- 17 (a) Findings.--The General Assembly finds and declares as
- 18 follows:
- 19 (1) While the exact number is not known, it is estimated
- that there are presently over 22,000 municipal police
- officers employed in this Commonwealth by over 1,000
- 22 political subdivisions.
- 23 (2) Each employing municipality or municipal authority
- 24 presently establishes its own form of identification for its
- 25 municipal police officers.
- 26 (3) While uniforms and badges or shields are the normal
- 27 form of identification for municipal police officers, other
- 28 than detectives and municipal police officers working
- 29 undercover, the type of uniform and metal badge or shield
- 30 worn by municipal police officers presently employed by these

- over 1,000 political subdivisions varies considerably.
- 2 (4) Due to the public's ability to easily obtain metal
- 3 police badges from mail order catalogs and uniform and pawn
- 4 shops, as well as from other sources, there has been over the
- 5 years a considerable number of cases in this Commonwealth in
- 6 which individuals with criminal intent have, by displaying a
- 7 metal badge, misrepresented themselves as municipal police
- 8 officers in this Commonwealth.
- 9 (5) With increasing frequency, this misrepresentation
- 10 has resulted in violent acts being taken against unsuspecting
- 11 members of the general public, resulting in bodily harm and
- 12 even death.
- 13 (b) Purpose. -- In order to provide the public greater
- 14 protection from individuals intent on misrepresenting themselves
- 15 as municipal police officers for whatever purpose, it is the
- 16 intent of this act to:
- 17 (1) Establish and have maintained by the Commonwealth a
- 18 centralized municipal police registry listing the names of
- 19 all municipal police officers currently employed at any given
- 20 time, and the name and address of the municipality or
- 21 municipal authority employing them.
- 22 (2) Create a uniform photo identification card for all
- 23 municipal police officers employed in this Commonwealth which
- 24 would include a recent photograph of the municipal police
- officer, would have to be carried by the municipal police
- 26 officer at all times while on duty and would have to be
- 27 updated biennially.
- 28 (3) Establish educational programs to alert children in
- this Commonwealth, as well as members of the general public,
- 30 to this new municipal police identification card system and

- 1 of their right to request to see proper photo identification
- 2 prior to accompanying anyone identifying himself as a
- 3 municipal police officer or providing him access to their
- 4 residence, vehicle or place of business.
- 5 Section 3. Definitions.
- 6 The following words and phrases when used in this act shall
- 7 have the meanings given to them in this section unless the
- 8 context clearly indicates otherwise:
- 9 "Commission." The Municipal Police Officers' Education and
- 10 Training Commission established pursuant to the act of June 18,
- 11 1974 (P.L.359, No.120), referred to as the Municipal Police
- 12 Education and Training Law.
- 13 "Department." The Department of Transportation of the
- 14 Commonwealth.
- 15 "Municipal authority security officer." Any full-time or
- 16 part-time private police officer or security officer, as
- 17 authorized and described in section 10(ee) and (ff) of the act
- 18 of May 28, 1937 (P.L.955, No.265), known as the Housing
- 19 Authorities Law, having the same powers and duties as a
- 20 municipal police officer employed in this Commonwealth and
- 21 required to be trained under the provisions of the act of June
- 22 18, 1974 (P.L.359, No.120), referred to as the Municipal Police
- 23 Education and Training Law.
- 24 "Municipal police department." Any bureau or department of a
- 25 political subdivision or municipal authority having general
- 26 police powers and charged with enforcing municipal ordinances
- 27 and with making arrests in connection with the enforcement of
- 28 criminal or traffic laws. The term shall include a political
- 29 subdivision or a municipal authority without a formal bureau or
- 30 department of police employing at least one police officer full

- 1 time or part time.
- 2 "Municipal police officer." Any full-time or part-time
- 3 employee of a city, borough, town, incorporated town, township
- 4 or county police department required to be trained under the
- 5 provisions of the act of June 18, 1974 (P.L.359, No.120),
- 6 referred to as the Municipal Police Education and Training Law,
- 7 as well as all municipal authority security officers employed in
- 8 this Commonwealth and required to be trained under the
- 9 provisions of the act of June 18, 1974 (P.L.359, No.120),
- 10 referred to as the Municipal Police Education and Training Law.
- 11 "Official State seal." A State seal identical to that
- 12 embossed on photo drivers' licenses currently issued by the
- 13 Department of Transportation.
- 14 "PennDOT photo license center." Any of the photo license
- 15 centers designated and authorized by the Department of
- 16 Transportation to prepare and issue photo drivers' licenses in
- 17 this Commonwealth.
- 18 "Photo identification card order form." A standard official
- 19 order form, to be prepared and initially supplied by the
- 20 Municipal Police Officers' Education and Training Commission and
- 21 subsequently ordered by a municipal police department, to be
- 22 used in the procurement of a uniform photo identification card
- 23 for a municipal police officer employed therein.
- 24 "Termination form." A standard official form prepared by the
- 25 Municipal Police Officers' Education and Training Commission
- 26 which is to be submitted to the commission by a municipal police
- 27 department at the time of the termination of employment of a
- 28 municipal police officer employed therein.
- 29 "Termination of employment." The discontinuance of
- 30 employment as a municipal police officer due to death, health

- 1 problems, mandatory or voluntary retirement, forced removal or
- 2 voluntary self-removal.
- 3 Section 4. Uniform municipal police photo identification card
- 4 system.
- 5 (a) Establishment.--There is hereby established in this
- 6 Commonwealth a uniform municipal police photo identification
- 7 card system to be administered by the commission. Photo
- 8 identification cards developed shall be issued biennially.
- 9 (b) Administration. -- The program shall be developed and
- 10 administered by the commission pursuant to the requirements of
- 11 section 7.
- 12 (c) Cooperation. -- The Department of Transportation and the
- 13 Department of Education shall cooperate with the commission in
- 14 the establishment and maintenance of the photo identification
- 15 card system established by this act, as required by sections 9
- 16 and 11 respectively.
- 17 (d) Utilization of uniform card.--All municipal police
- 18 officers employed in this Commonwealth after the effective date
- 19 of this act shall, with the exception of plainclothes municipal
- 20 police officers involved in undercover investigations, be
- 21 required to carry while on duty and present upon request, when
- 22 offering assistance to the public or when making an arrest, the
- 23 uniform photo identification card developed by the commission.
- 24 (e) Biennial renewal.--Municipal police officers shall
- 25 obtain a new photo identification card biennially pursuant to
- 26 the requirements of section 10.
- 27 Section 5. Centralized official municipal police registry.
- 28 (a) Establishment.--There is hereby established in this
- 29 Commonwealth a centralized official municipal police registry to
- 30 be administered by the commission.

- 1 (b) Administration.--The registry shall be developed and
- 2 maintained by the commission pursuant to the requirements of
- 3 section 8.
- 4 (c) Cooperation.--All municipal police officers and
- 5 municipal police departments, as well as PennDOT, shall
- 6 cooperate with the commission in the establishment and
- 7 maintenance of the official municipal police registry as
- 8 required by sections 8 and 9 respectively.
- 9 Section 6. Information from registry.
- 10 The computerized registry established and maintained by the
- 11 commission pursuant to this act shall provide immediate and
- 12 accurate information relative to the current employment status
- 13 of all municipal police officers employed in this Commonwealth
- 14 at any given time, when the need for such verification shall
- 15 arise. The commission shall develop a policy with respect to
- 16 access to the registry by the media, other law enforcement
- 17 agencies and the general public.
- 18 Section 7. Administration of photo identification card system.
- 19 (a) Notification.--
- 20 (1) Within 90 days following the effective date of this
- act, the commission shall be required to notify all municipal
- 22 police departments within this Commonwealth, in writing, of
- 23 the provisions of this act, the responsibilities of the
- 24 municipal police department and the responsibilities of all
- 25 municipal police officers employed by such department.
- 26 (2) Within 60 days of receipt of the written
- 27 notification from the commission, each municipal police
- department shall notify the commission, in writing, of the
- 29 names of all full-time and part-time municipal police
- 30 officers employed by such department at that time, pursuant

- 1 to the requirements of section 10.
- 2 (b) Establishment of format.--
- 3 (1) The commission shall have six months from the 4 effective date of this act to establish a standard format for 5 the photo identification card and to develop and have printed 6 a standard photo identification card order form.
- 7 (2) Prior to the termination of this initial six-month 8 period, the commission shall send the necessary number of 9 photo identification card order forms to each municipal 10 police department within this Commonwealth, based on the 11 information submitted by the municipal police departments to 12 the commission as required by subsection (a)(2).
- (3) The photo identification card order form shall

 consist of four color-coded single-page detachable copies.

 Printed clearly on each detachable page of the four-page

 order form shall be an indication as to who is to retain that

 particular copy, and, in the case of the commission's copy,

 the commission's current mailing address and who is
- 19 responsible for forwarding it to the commission. 20 (c) Municipal duty.--Upon receipt by the municipal police department of the order forms from the commission, the police 21 chief or individual responsible for the direct supervision of 22 23 municipal police officers shall insure that the requested information is typed on page one of the order form for each 24 municipal police officer employed by the municipality or 25 26 municipal authority and that the appropriate form is then provided to each municipal police officer to have notarized and 27 28 to take to a PennDOT photo license center for processing pursuant to section 9. 29
- 30 (d) Division of order form.--Upon surrender of the photo

- 1 identification card order form at the PennDOT photo license
- 2 center by the municipal police officer, and the taking of the
- 3 photograph, the order form is to be divided as follows:
- 4 (1) One copy is to be sent by the department to the
- 5 commission.
- 6 (2) One copy is to be kept by the department.
- 7 (3) One copy is to be kept by the employing municipal
- 8 police department.
- 9 (4) One copy is to be kept by the municipal police
- 10 officer for the personal record of the officer.
- 11 (e) Information on order form.--The information to be
- 12 provided on the photo identification card order form shall be as
- 13 follows:
- 14 (1) The municipal police officer's full name, Social
- 15 Security number, weight, height, race, date of birth, sex,
- 16 eye color and employment status, whether full time or part
- 17 time.
- 18 (2) A serial number issued by the commission identical
- 19 to the photo identification card order form number.
- 20 (3) Name, address and telephone number of the municipal
- 21 police department where the municipal police officer is
- 22 currently employed.
- 23 (4) Signature space for the municipal police officer.
- 24 (5) Signature space for the individual taking the
- 25 photograph at the PennDOT photo license center and the date
- taken.
- 27 (6) Such other information as the commission may
- 28 require.
- 29 (f) Information on photo card. -- The information under
- 30 subsection (e) shall also appear on the uniform photo

- 1 identification card developed by the commission. In addition,
- 2 the following information shall be present:
- 3 (1) The official State seal of the Commonwealth.
- 4 (2) A standard color field, to be determined by the
- 5 commission and changed biennially.
- 6 (3) The municipal police officer's official photo.
- 7 (4) The expiration date, which shall correspond to two
- 8 years from the date the information was entered onto page one
- 9 of the photo identification card order form.
- 10 (g) Biennial update. -- The commission shall require that the
- 11 municipal police officer's photo and the information appearing
- 12 on the photo identification card be updated biennially and shall
- 13 notify all municipal police departments at the appropriate
- 14 times.
- 15 (h) Termination forms.--
- 16 (1) The commission, during the initial six months
- following the effective date of this act, shall also develop
- and have printed for distribution to all municipal police
- 19 departments, standard termination forms to be used at the
- time of a municipal police officer's termination of
- 21 employment.
- 22 (2) At the time any employed municipal police officer
- 23 terminates employment for any reason, the municipal police
- 24 department employing that officer shall obtain from the
- officer the photo identification card, which shall be
- 26 submitted by the municipal police department to the
- 27 commission, along with the termination form, pursuant to the
- requirements of section 10(c).
- 29 (3) The commission, upon receipt of the termination form
- 30 and accompanying photo identification card from a municipal

- 1 police department, shall destroy the issued card and correct
- 2 its records and police registry accordingly.
- 3 (4) Municipal police officers who terminate employment
- 4 with one municipal police department and who are subsequently
- 5 rehired by another municipal police department in this
- 6 Commonwealth shall surrender their current photo
- 7 identification cards required by this act at the time their
- 8 employment with the first police department is terminated.
- 9 Upon their employment by another municipal police department,
- 10 they shall follow the procedures provided under section 10(b)
- 11 to obtain a new photo identification card.
- 12 (i) Lost or stolen cards.--The commission shall be
- 13 responsible for the development of a policy for cases in which
- 14 municipal police photo identification cards are lost or stolen.
- 15 (j) Temporary surrender of card.--The commission shall be
- 16 responsible for the development of rules and regulations
- 17 governing the temporary surrender of a photo identification card
- 18 by a municipal police officer charged with a criminal offense or
- 19 in any other case which the commission may deem appropriate.
- 20 Section 8. Centralized official municipal police registry.
- 21 (a) Establishment.--The commission, through its own staff or
- 22 by contract, shall, within 12 months following the effective
- 23 date of this act, develop and implement a central computerized
- 24 data base for all municipal police officers employed in this
- 25 Commonwealth. This data base shall be referred to as the
- 26 Official Municipal Police Registry.
- 27 (b) Comprehensive record capability. -- This centralized data
- 28 base is to provide a comprehensive record of all municipal
- 29 police officers employed in this Commonwealth and shall include,
- 30 but not be limited to, information delineated on the photo

- 1 identification card order form described in section 7(e).
- 2 (c) Information input.--
- 3 (1) The commission, upon receipt of its copy of the
- 4 photo identification card order form, as provided by section
- 5 9(b), shall cause this information to be immediately entered
- 6 into the computerized municipal police registry maintained by
- 7 the commission.
- 8 (2) All information obtained from the photo
- 9 identification cards system established by this act shall be
- 10 entered by the commission into the computerized central data
- 11 base no later than 12 months following the effective date of
- 12 this act.
- 13 (d) Record updates.--It shall be the responsibility of the
- 14 commission to update the employment record of all municipal
- 15 police officers employed in this Commonwealth biennially as new
- 16 photo identification cards are issued. Changes relative to
- 17 employment status resulting from the termination of employment
- 18 shall be entered into the computerized registry immediately upon
- 19 the commission's receipt of the termination form from the
- 20 municipal police department employing the affected municipal
- 21 police officer.
- 22 Section 9. Department of Transportation.
- 23 (a) Card preparation. -- The department shall authorize its
- 24 existing photo license centers to prepare and issue, biennially,
- 25 a photo identification card to each municipal police officer
- 26 employed in this Commonwealth upon the presentation by the
- 27 municipal police officer, at a PennDOT photo license center, of
- 28 a notarized photo identification card order form described in
- 29 section 7(e), pursuant to the procedures provided for in section
- 30 10(b).

- 1 (b) Signature and transmission of copies.--Upon the issuance
- 2 of the photo identification card to the municipal police
- 3 officer, the individual issuing the card for the department
- 4 shall sign and date the appropriate copy of the order form
- 5 acknowledging the issuance of the card. This copy shall be sent
- 6 by the department to the commission for its records in order to
- 7 insure that all municipal police officers employed in this
- 8 Commonwealth have complied with the provisions of this act. One
- 9 copy of the order form so indicated shall be retained by the
- 10 department for its records. The remaining two copies of the
- 11 order form shall be given back to the municipal police officer
- 12 upon the issuance of the photo identification card. One of these
- 13 two copies so indicated is to be retained by the municipal
- 14 police officer for his personal records, and one copy is to be
- 15 returned to the municipal police department where he is employed
- 16 for its permanent record.
- 17 (c) Reimbursement.--The commission shall reimburse the
- 18 department for all administrative and preparation costs incurred
- 19 in carrying out its responsibilities under this act, initially,
- 20 and in subsequent years, as updated photo identification cards
- 21 are issued.
- 22 Section 10. Responsibilities of municipal police and security
- officers and municipal police departments.
- 24 (a) Listing of municipal police officers employed.--All
- 25 municipal police departments in this Commonwealth shall, within
- 26 60 days of receipt from the commission of a written description
- 27 of their duties and responsibilities and the responsibilities of
- 28 the municipal police officers employed by them, as required
- 29 section 7(a)(1), prepare and submit in writing to the
- 30 commission, a list of names of all full-time and part-time

- 1 municipal police officers currently employed. Following the
- 2 receipt of this list, the commission shall mail to each
- 3 municipal police department submitting names the appropriate
- 4 number of photo identification card order forms. Additional
- 5 forms may be ordered from the commission by any municipal police
- 6 department at the time any new municipal police officer is
- 7 employed.
- 8 (b) Responsibilities of municipal police officers.--Upon
- 9 receipt by a municipal police officer of a photo identification
- 10 card order form pursuant to the procedures described in section
- 11 7(c), the municipal police officer shall have 15 days in which
- 12 to have the photo identification cards order form notarized and
- 13 to present the order form at a PennDOT photo license center for
- 14 processing and the issuance of a photo identification card as
- 15 provided for by this act.
- 16 (c) Termination of employment. -- Upon the termination of
- 17 employment with a municipal police department, for any reason,
- 18 by a municipal police officer in possession of a photo
- 19 identification card issued pursuant to the requirements of this
- 20 act, the photo identification card shall be immediately
- 21 surrendered, by the municipal police officer or the estate, to
- 22 the municipal police department to be forwarded by the municipal
- 23 police department to the commission, along with the termination
- 24 form described in section 7(h)(1).
- 25 (d) Penalties.--
- 26 (1) Any municipal police officer who fails to obtain a
- 27 uniform photo identification card pursuant to the
- 28 requirements and time limitations established by this act, or
- 29 who upon termination of employment fails to immediately
- 30 surrender the photo identification card to the municipal

- 1 police department where he was last employed commits a
- 2 summary offense and shall be personally liable for the cost
- of any subsequent photo identification cards which may be
- 4 issued to that municipal police officer.
- 5 (2) The failure of any municipal police department to
- 6 meet the requirements of this act shall result in that
- 7 municipal police department being responsible for all costs
- 8 associated with the issuance of the initial photo
- 9 identification card for municipal police officers currently
- 10 employed, or for the cost of the issuance of all photo
- identification cards issued in the future to municipal police
- officers employed by the municipal police department, which
- costs would normally be paid by the commission.
- 14 (3) Any person who forges or alters a uniform police
- 15 identification card as described in this act, or who is in
- 16 possession of a forged or altered card, commits a felony of
- 17 the second degree.
- 18 (e) Withholding of moneys for noncompliance. -- In addition to
- 19 any other penalties, the Governor shall have the discretion to
- 20 withhold any and all moneys due the municipality served by the
- 21 municipal police department failing to meet the requirements of
- 22 this act, until the provisions of this act are fully complied
- 23 with to the satisfaction of the commission.
- 24 (f) Municipal costs.--The municipal police photo
- 25 identification card issued under provisions of this act shall be
- 26 provided at no cost to all municipal police officers employed in
- 27 this Commonwealth and shall be paid for by the commission except
- 28 as provided under subsection (d). All administrative costs
- 29 incurred by a municipal police department in complying with the
- 30 requirements of this act, including notarization costs

- 1 associated with the photo identification card order form, shall
- 2 be paid for by the respective municipal police departments.
- 3 Section 11. Establishment of educational programs to promote
- 4 public awareness.
- 5 (a) Cooperation. -- The Department of Education and the
- 6 commission shall cooperate in the creation of educational
- 7 programs to promote greater public awareness of:
- 8 (1) The new uniform municipal police photo
- 9 identification card system.
- 10 (2) The official municipal police registry.
- 11 (3) The public's right to request to see proper photo
- identification prior to accompanying anyone identifying
- himself as a municipal police officer or providing the
- 14 individual access to a residence, vehicle or place of
- 15 business.
- 16 (b) Commission educational program. -- The commission shall,
- 17 during the first 12 months immediately following the passage of
- 18 this act, prepare or have prepared, by contract, public
- 19 awareness educational programs to accomplish the objectives of
- 20 this section. These educational public awareness programs are to
- 21 begin 12 months following the effective date of this act and
- 22 shall continue as long as the commission deems necessary,
- 23 provided that funds are available.
- 24 (c) Assistance in development. -- The Department of Education
- 25 shall assist the commission in the development of educational
- 26 programs to be implemented within the public and private
- 27 elementary and secondary schools of this Commonwealth. These
- 28 programs shall include, but not be limited to, written
- 29 literature, school assembly programs, films, etc. The commission
- 30 shall reimburse the Department of Education for any costs

- 1 incurred by the department in assisting the commission in the
- 2 preparation and implementation of the programs.
- 3 (d) Statewide disbursement.--In order to promote awareness
- 4 on the part of the general public of the objectives of this
- 5 section, the commission shall solicit the Statewide involvement
- 6 of appropriate community service groups and organizations, as
- 7 well as Statewide representatives of the media, in the
- 8 development of public service announcements for radio,
- 9 television and the print media, as well as advertising campaigns
- 10 and other public relations programs. The commission may
- 11 reimburse participants for any direct expenses incurred which
- 12 the commission deems appropriate.
- 13 Section 12. Reports.
- 14 The commission shall, at the end of 24 months following the
- 15 effective date of this act, provide a written report to the
- 16 General Assembly, which report shall:
- 17 (1) Itemize all expenses incurred to date and moneys
- 18 remaining from the initial appropriation, if any.
- 19 (2) Describe any problems associated with implementing
- 20 the provisions of this act and make recommendations for
- 21 resolving any problems.
- 22 (3) Estimate annual appropriations which will be needed
- 23 by the commission in the future to properly maintain and
- 24 update the municipal police photo identification card system
- and registry established by this act.
- 26 Section 13. Appropriation.
- The sum of \$2,000,000, or as much thereof as may be
- 28 necessary, is hereby appropriated from the General Fund to the
- 29 Municipal Police Officers' Education and Training Commission for
- 30 the fiscal year July 1, 1991, to June 30, 1992, to pay for all

- 1 costs associated with meeting the requirements of this act.
- 2 Section 14. Effective date.
- This act shall take effect immediately. 3
