AN ACT

Authorizing the incurring of indebtedness, with approval of the electors, for the payment of compensation for service in or in support of the Persian Gulf Conflict, for payment of the cost of armed conflict service medals and for payment of the cost of selecting, designing, constructing and maintaining a patriotic monument or memorial in appreciation of Pennsylvania's veterans.

8 The General Assembly of the Commonwealth of Pennsylvania

9 hereby enacts as follows:

10 Section 1. Question.

11 The question of incurring indebtedness of \$50,000,000 for the 12 purposes set forth in this section shall be submitted to the 13 electors at the next primary, municipal or general election 14 following enactment of this act. This indebtedness shall be for 15 the purpose of the following: 1 (1) Providing compensation to persons who have served in 2 the Persian Gulf theater of operations during armed conflict 3 or who have been called to active duty for the support of the 4 armed conflict in the Persian Gulf or to the representatives 5 of such persons who, because of death or incapacity, cannot 6 personally receive compensation.

7 (2) For payment of the costs of providing for a
8 Pennsylvania Armed Conflict Service Medal to veterans of
9 armed conflicts.

10 (3) For payment of the costs of selecting, designing, 11 constructing and maintaining a patriotic memorial on the 12 grounds of the Indiantown Gap National Cemetery in 13 appreciation of the measure of sacrifice and devotion given 14 by veterans of this Commonwealth.

15 Section 2. Certification.

16 The Secretary of the Commonwealth shall certify the question 17 under section 1 to the county boards of elections.

18 Section 3. Form of question.

19 The question under section 1 shall be in substantially the 20 following form:

21 Do you favor the incurring of indebtedness by the 22 Commonwealth of \$50,000,000 for the payment of 23 compensation for service in or in support of the Persian 24 Gulf Conflict, for the cost of armed conflict service 25 medals and for the cost of constructing and maintaining a 26 patriotic monument or memorial in appreciation of 27 Pennsylvania's veterans?

28 Section 4. Election.

29 The election shall be conducted in accordance with the act of 30 June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania 19910H0803B0886 - 2 - Election Code, except that the time limits for advertisement of
 notice of the election may be waived as to the question.

3 Section 5. Proceeds.

4 Proceeds of borrowing shall be used for the payment of 5 compensation for service in or in support of the Persian Gulf 6 Conflict, for the cost of armed conflict service medals and the 7 cost of selecting, designing, constructing and maintaining a 8 patriotic monument or memorial in appreciation of Pennsylvania's 9 veterans.

10 Section 6. Effective date.

11 This act shall take effect immediately.
