AN ACT

- Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying 3 and enumerating certain subjects of taxation and imposing taxes thereon; providing procedures for the payment, collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and 7 imposing duties upon the Department of Revenue, certain employers, fiduciaries, individuals, persons, corporations 9 and other entities; prescribing crimes, offenses and penalties, excluding batteries for artificial hearing 10 devices from sales and use tax. 11
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- Section 1. Section 204(17) of the act of March 4, 1971
- 15 (P.L.6, No.2), known as the Tax Reform Code of 1971, amended
- 16 July 20, 1974 (P.L.535, No.183), is amended to read:
- 17 Section 204. Exclusions from Tax. -- The tax imposed by
- 18 section 202 shall not be imposed upon

- 20 (17) The sale at retail or use of prescription or non-

- 1 prescription medicines, drugs or medical supplies, crutches and
- 2 wheelchairs for the use of cripples and invalids, artificial
- 3 limbs, artificial eyes and artificial hearing devices when
- 4 designed to be worn on the person of the purchaser or user,
- 5 <u>batteries for such artificial hearing devices</u>, false teeth and
- 6 materials used by a dentist in dental treatment, eyeglasses when
- 7 especially designed or prescribed by an ophthalmologist, oculist
- 8 or optometrist for the personal use of the owner or purchaser
- 9 and artificial braces and supports designed solely for the use
- 10 of crippled persons or any other therapeutic, prosthetic or
- 11 artificial device designed for the use of a particular
- 12 individual to correct or alleviate a physical incapacity,
- 13 including but not limited to hospital beds, iron lungs, and
- 14 kidney machines.

- 16 Section 2. This act shall take effect in 60 days.
