## AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 2 Statutes, providing for certain SPECIAL registration plates. <—
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Title 75 of the Pennsylvania Consolidated
- 6 Statutes is amended by adding sections to read:
- 7 § 1350. Special plates for recipients of Silver Star.
- 8 Upon application of a person who is a recipient of the Silver
- 9 Star, ACCOMPANIED BY A FEE OF \$20 WHICH SHALL BE IN ADDITION TO
- 10 THE ANNUAL REGISTRATION FEE AND BY SUCH DOCUMENTATION AS THE
- 11 DEPARTMENT SHALL REQUIRE, the department shall issue to that THE <---
- 12 person a special registration plate designating the vehicle so
- 13 <u>licensed as belonging to a person who is a recipient of the</u>
- 14 Silver Star. THE SPECIAL REGISTRATION PLATE MAY BE USED ON ONLY <-
- 15 ONE PASSENGER VEHICLE OR ONE OTHER VEHICLE WITH A REGISTERED

- 1 GROSS WEIGHT OF NOT MORE THAN 9,000 POUNDS.
- 2 § 1351. Special plates for recipients of the Army Distinguished
- 3 <u>Service Cross, Navy Cross or Air Force Cross.</u>
- 4 Upon application of a person who is a recipient of the Army
- 5 <u>Distinguished Service Cross</u>, Navy Cross or Air Force Cross,
- 6 ACCOMPANIED BY A FEE OF \$20 WHICH SHALL BE IN ADDITION TO THE
- 7 ANNUAL REGISTRATION FEE AND BY SUCH DOCUMENTATION AS THE
- 8 DEPARTMENT SHALL REQUIRE, the department shall issue to that
- 9 person a special registration plate designating the vehicle so
- 10 licensed as belonging to a person who is a recipient of the Army
- 11 <u>Distinguished Service Cross, Navy Cross or Air Force Cross. THE</u> <-
- 12 SPECIAL REGISTRATION PLATE MAY BE USED ON ONLY ONE PASSENGER
- 13 VEHICLE OR ONE OTHER VEHICLE WITH A REGISTERED GROSS WEIGHT OF
- 14 NOT MORE THAN 9,000 POUNDS.
- 15 Section 2. This act shall take effect in 60 days.
