AN ACT

- 1 Authorizing and directing the Department of General Services,
- with the approval of the Governor, to convey a right-of-way
- 3 in East Vincent Township, Chester County, Pennsylvania.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. The Department of General Services, with the
- 7 approval of the Governor, is hereby authorized and directed, on
- 8 behalf of the Commonwealth of Pennsylvania, to grant and convey
- 9 to David A. Buchanan and L. Victoria Brien of Spring City,
- 10 Pennsylvania, for a consideration of fair market value as
- 11 determined by an appraisal of the Department of General
- 12 Services, an easement and right-of-way as follows:
- Beginning at a point in the middle of Dunlap Road in East
- 14 Vincent Township, Chester County, Pennsylvania and bearing North
- 15 07 degrees 45 minutes 58 seconds East along lands of Spring
- 16 Hollow Golf Course, Inc. 459 feet to lands of the grantees,
- 17 described in Deed Book 1425, Page 405 etc. and continuing along
- 18 land of grantees 50 feet to a point; thence South 82 degrees 8

- 1 minutes, 30 seconds East 50 feet to a point; thence South 07
- 2 degrees, 45 minutes, 58 seconds West 509 feet over the said land
- 3 of grantor described in Deed Book U-19, Page 307, to a point in
- 4 the center of Dunlap Road; thence North 82 degrees 8 minutes, 30
- 5 seconds, West to the place of beginning.
- 6 Section 2. The conveyance shall be made under and subject to
- 7 all easements, servitudes and rights of others, including, but
- 8 not confined to, streets, roadways and rights of telephone,
- 9 telegraph, water, electric, sewer, gas or pipeline companies, as
- 10 well as under and subject to any interest, estates or tenancies
- 11 vested in third persons, whether or not appearing of record, for
- 12 any portion of the land or improvements erected thereon.
- 13 Section 3. The deed of conveyance shall be approved as
- 14 provided by law and shall be executed by the Secretary of the
- 15 Department of General Services in the name of the Commonwealth
- 16 of Pennsylvania and delivered to the grantee within 60 days
- 17 after the effective date of this act.
- 18 Section 4. Costs and fees incidental to the conveyance shall
- 19 be borne by the grantee.
- 20 Section 5. This act shall take effect in 60 days.
