## AN ACT

- 1 Amending Title 24 (Education) of the Pennsylvania Consolidated
- 2 Statutes, further providing for credited school service and
- 3 for termination of annuities.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 8302 of Title 24 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a subsection to read:
- 8 § 8302. Credited school service.
- 9 \* \* \*
- 10 (b.2) Credited service as retirement incentive.--
- 11 Notwithstanding any provisions of this title to the contrary,
- 12 for the period of August 1, 1992, to July 31, 1993, a member who
- 13 is not an annuitant on August 1, 1992, who terminates school
- 14 service between August 1, 1992, and July 31, 1993, inclusive,
- 15 and who is during that period 55 years of age or older shall be
- 16 credited with an additional 10% of his credited service.

- 1 Section 2. Section 8346(a) of Title 24 is amended to read:
- 2 § 8346. Termination of annuities.
- 3 (a) General rule.--If an annuitant returns to school service
- 4 or enters State service and elects multiple service membership,
- 5 any annuity payable to him under this part shall cease and in
- 6 the case of an annuity other than a disability annuity the
- 7 present value of such annuity, adjusted for full coverage in the
- 8 case of a joint coverage member who makes the appropriate back
- 9 contributions for full coverage, shall be frozen as of the date
- 10 such annuity ceases. An annuitant who is credited with an
- 11 <u>additional 10% of membership service as provided in section</u>
- 12 8302(b.1) (relating to credited school service) and who returns
- 13 to school service, except as provided in subsection (b) shall
- 14 forfeit such credited service and shall have his frozen present
- 15 <u>value adjusted as if his 10% retirement incentive had not been</u>
- 16 applied to his account. In the event that the cost-of-living
- 17 increase enacted December 18, 1979 occurred during the period of
- 18 such State or school employment, the frozen present value shall
- 19 be increased, on or after the member attains superannuation age,
- 20 by the percent applicable had he not returned to service.

- 22 Section 3. This act shall take effect immediately.
