## AN ACT

1 Amending the act of July 9, 1992 (P.L. , No.39A), entitled "An  
2 act appropriating money from the Sunny Day Fund to the  
3 Department of Commerce for various projects throughout this  
4 Commonwealth for fiscal year 1992-1993," further defining AND <—  
5 ADDING a project; and making an appropriation.

6 The General Assembly of the Commonwealth of Pennsylvania  
7 hereby enacts as follows:

8 Section 1. Section 2~~(1)~~ of the act of July 9, 1992 (P.L. , <—  
9 No.39A), entitled "An act appropriating money from the Sunny Day  
10 Fund to the Department of Commerce for various projects  
11 throughout this Commonwealth for fiscal year 1992-1993," is  
12 amended to read:

13 Section 2. The following amounts are appropriated to the  
14 Department of Commerce to induce companies to locate large  
15 industrial, manufacturing or research and development  
16 enterprises within this Commonwealth:

17 (1) For the purpose of making a loan to  
18 Murry's, Inc., a vertically integrated meat and

1 poultry processing company, to expand its existing  
 2 facility in Lebanon through the acquisition of  
 3 land, the construction of an 80,000 square foot  
 4 processing and distribution facility [in the city  
 5 of Lebanon's enterprise zone.] within Lebanon  
 6 County and the acquisition of machinery and  
 7 equipment. Murry's, Inc., will invest at least  
 8 \$12,000,000 into the project, which will create  
 9 approximately 200 new jobs within three years of  
 10 operation..... [\$1,000,000]

13 (2) FOR THE PURPOSE OF MAKING A LOAN TO U.S. ←  
 14 BIOSCIENCE, A COMPANY INVOLVED IN THE DEVELOPMENT ←  
 15 AND COMMERCIALIZATION OF NEW CANCER TREATMENTS AND  
 16 ALLIED DISEASES, TO LOCATE A PHARMACEUTICAL  
 17 PRODUCTION FACILITY IN CHESTER OR MONTGOMERY  
 18 COUNTY. U.S. BIOSCIENCE WILL INVEST AT LEAST  
 19 \$50,000,000 INTO THE PROJECT, WHICH WILL CREATE  
 20 APPROXIMATELY 270 NEW JOBS WITHIN THREE YEARS OF  
 21 OPERATION..... \$2,000,000

22 (3) FOR THE PURPOSE OF MAKING A LOAN TO BLUE  
 23 CHIP PRODUCTS, INC., A MANUFACTURER/REMANUFACTURER  
 24 OF AUTOMOTIVE PARTS FOR THE AUTOMOTIVE  
 25 AFTERMARKET, FOR BUILDING ACQUISITION AND  
 26 RENOVATIONS TO BE MADE IN CONNECTION WITH THE  
 27 CONSOLIDATION/RELOCATION OF ALL OF BLUE CHIP  
 28 PRODUCTS, INC.'S OPERATIONS TO FALLS TOWNSHIP,  
 29 BUCKS COUNTY, AND THE INTRODUCTION OF NEW PRODUCT  
 30 LINES. IT IS ESTIMATED THAT THIS PROJECT WILL

1 RESULT IN THE RETENTION OF 300 EXISTING  
2 PENNSYLVANIA JOBS AND THE CREATION, WITHIN THREE  
3 YEARS OF OPERATION, OF 700 NEW JOBS (400 JOBS  
4 RESULTING FROM THE MARYLAND RELOCATION AND 300  
5 JOBS RESULTING FROM THE NEW PRODUCT LINES).....      \$3,000,000

6        Section 2. This act shall take effect immediately.
