A RESOLUTION

1 Amending House Rule 18.

2 RESOLVED, That the House of Representatives amend Rule 18 of
3 the Rules of the House of Representatives to read:

4 RULE 18

5 Introduction and Printing of Bills

6 Bills shall be introduced in quadruplicate, signed and dated
7 by each member who is a sponsor of the bill, and filed with the
8 Chief Clerk. A sponsor may be added or withdrawn upon written
9 notice to the Speaker, Majority Leader, Minority Leader and the
10 prime sponsor. In the case of withdrawals, the names shall be
11 withdrawn if and when the bill is reprinted. If a bill is
12 amended so that all of its provisions are stricken and new
13 provisions are added, the names of all of the sponsors of the

1 bill shall be removed and replaced with the name of the sponsor
2 of the amendment. Additional sponsors may be added only by the
3 prime sponsor by providing written notice to the Speaker,
4 Majority Leader and Minority Leader. Such notice shall include
5 the signatures of those members desiring to be additional
6 sponsors.

7 Bills introduced when received at the Chief Clerk's desk
8 shall be numbered consecutively and delivered to the Speaker,
9 who shall refer each bill to an appropriate committee. The
10 Speaker shall report to the House the committees to which bills
11 have been referred, either on the day introduced or received or
12 on the next two legislative days the House is in session.

13 If the Speaker neglects or refuses to refer to committee any
14 bill or bills (whether House or Senate) as above after
15 introduction or presentation by the Senate for concurrence, any
16 member may move for the reference of the bill to an appropriate
17 committee. If the motion is carried, said bill or bills shall be
18 immediately surrendered by the Speaker to the committee
19 designated in said motion.

20 The first copy of each bill introduced shall be for the
21 committee, the second copy shall be for the printer, the third
22 copy shall be for the news media and the fourth copy shall be
23 for the Legislative Reference Bureau.

24 Every bill, after introduction and reference to committee,
25 shall be printed.

26 Bills may not be withdrawn after reference to committee.
